The filing fee for Form I-829 is \$3,750. A biometric services fee of \$85 is also required for the petitioners, as well as any current spouse, former conditional permanent resident spouse, or conditional permanent resident children that are included on the petition between 14 and 79 years of age. That means you must submit a separate biometric services fee of \$85 for each conditional permanent resident who is applying with you to remove the conditions
