

**SUPPORTING STATEMENT FOR  
Petition for Nonimmigrant Worker: H-2A Classification  
OMB Control No.: 1615-0150  
COLLECTION INSTRUMENT(S): Form I-129H2A**

**A. Justification**

- 1. Explain the circumstances that make the collection of information necessary. Identify any legal or administrative requirements that necessitate the collection. Attach a copy of the appropriate section of each statute and regulation mandating or authorizing the collection of information.**

USCIS needs the information collected on Form I-129H2A, the Named Worker Attachment, and the Joint Employer Supplement to determine whether the petitioner and foreign national beneficiary(ies) are eligible for the H-2A nonimmigrant classification. The statutory authority is section 101(a)(15) and 214(c)(1); 8 U.S.C. 1101(a)(15) and 1184(c)(1) of the Immigration and Nationality Act (INA) and the regulatory authority is 8 CFR 214.2 (h)(2)(i)(A). A U.S. employer, or agent in some instances, may file a petition to employ foreign nationals as an H-2A nonimmigrant worker.

In addition to the collection of data entries directly on the form and its supplement, this form also provides the avenue through which employers or agents submit documentary evidence to establish eligibility for the nonimmigrant classification being sought. DHS may collect and store for present or future use, by electronic or other means, the biometric information submitted by an individual. DHS may use this biometric information to conduct background and security checks, adjudicate the nonimmigrant petition, and perform other functions related to administering and enforcing the immigration and nationality laws.

**Authority:** See section 214 of the Act and 8 CFR 214.2, especially 8 CFR and 8 CFR 214.2(h)(19)(iii)(B).

- 2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.**

USCIS uses the data collected on this form to determine eligibility for the requested H-2A nonimmigrant petition and/or requests to extend or change nonimmigrant status. An employer or agent uses this form to petition USCIS for an alien to temporarily enter as a nonimmigrant. An employer or agent also uses this form to request an extension of stay or change of status on behalf of the alien worker. The form serves the purpose of standardizing requests for H-2A nonimmigrant workers, and ensuring that basic information required for assessing eligibility is provided by the petitioner. It also assists USCIS in compiling information required by Congress to assess effectiveness and

utilization of certain nonimmigrant classifications.

- 3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g., permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration of using information technology to reduce burden.**

The use of the Form I-129H2A provides the most efficient means for collecting and processing the required data. This form and its instructions reside on the USCIS website at <http://www.uscis.gov/i-129>. The form and the instructions can be downloaded, completed, and saved electronically, but the form must be mailed to USCIS.

- 4. Describe efforts to identify duplication. Show specifically why any similar information already available cannot be used or modified for use for the purposes described in Item 2 above.**

USCIS has no other information collections that request the information needed to adjudicate petitions for nonimmigrant workers in an H-2A classification.

- 5. If the collection of information impacts small businesses or other small entities (Item 5 of OMB Form 83-I), describe any methods used to minimize burden.**

Form I-129H2A may have an impact on small businesses. The form requests only that information which is needed by officers to determine the petitioner's and beneficiary's/ies' eligibility. This includes information that will reduce the likelihood that USCIS may need to issue a request for evidence (RFE) to the petitioner upon review of the petition and initial evidence submission. USCIS has included information in the instructions of the Form I-129H2A to provide additional guidance to assist small businesses with the completion of the form as well as guidance for filing multiple petitions.

- 6. Describe the consequence to Federal program or policy activities if the collection is not conducted or is conducted less frequently, as well as any technical or legal obstacles to reducing burden.**

Without Form I-129H2A, USCIS would not have the information needed to determine if the petitioner and the requested nonimmigrant workers are eligible for classification as H-2A nonimmigrants.

- 7. Explain any special circumstances that would cause an information collection to be conducted in a manner:**

- Requiring respondents to report information to the agency more often than quarterly;**

- **Requiring respondents to prepare a written response to a collection of information in fewer than 30 days after receipt of it;**
- **Requiring respondents to submit more than an original and two copies of any document;**
- **Requiring respondents to retain records, other than health, medical, government contract, grant-in-aid, or tax records for more than three years;**
- **In connection with a statistical survey, that is not designed to produce valid and reliable results that can be generalized to the universe of study;**
- **Requiring the use of a statistical data classification that has not been reviewed and approved by OMB;**
- **That includes a pledge of confidentiality that is not supported by authority established in statute or regulation, that is not supported by disclosure and data security policies that are consistent with the pledge, or which unnecessarily impedes sharing of data with other agencies for compatible confidential use; or**
- **Requiring respondents to submit proprietary trade secret, or other confidential information unless the agency can demonstrate that it has instituted procedures to protect the information's confidentiality to the extent permitted by law.**

This information collection is conducted in a manner consistent with the guidelines in 5 CFR 1320.5(d)(2).

On November 14, 2019, USCIS published a Notice of Proposed Rulemaking in the Federal Register at 84 FR 62280. USCIS did receive comments on this information collection and has responded to them in the preamble of the 2018 Fee Final Rulemaking (1615-AC18).

On August 3, 2020, USCIS published a Final Rulemaking in the Federal Register at 85 FR 46788.

**9. Explain any decision to provide any payment or gift to respondents, other than remuneration of contractors or grantees.**

USCIS does not provide payments or gifts to respondents in exchange for a benefit sought.

**10. Describe any assurance of confidentiality provided to respondents and the basis for the assurance in statute, regulation or agency policy.**

There is no assurance of confidentiality.

The privacy impact assessments associated with this information collection are:

- DHS/USCIS/PIA-016 Computer Linked Application Information Management System (CLAIMS 3) and Associated Systems, which covers the processing and adjudication of I-129H2A; and
- DHS/USCIS/PIA-061 Benefit Request Intake Process, which covers the processing of I-129H1.

**11. Provide additional justification for any questions of a sensitive nature, such as sexual behavior and attitudes, religious beliefs, and other matters that are commonly considered private. USCIS uses the SSN along with other sensitive biographic information to verify the

identity of the individual and to determine employee’s eligibility for the benefit sought. In the case of an individual employer or sole proprietor, the SSN may be used as a taxpayer identification number by the Internal Revenue Service. The form now captures relevant information to determine the employer’s eligibility and confirm the petitioner’s identity. This information is required to ensure proper identification of the individuals listed in the petition and helps USCIS to positively identify individuals when other available data, such as names and date of birth, is the same as or similar to another individual’s information. USCIS currently does not collect fingerprints for Form I-129H2A (with the exception of a very limited number of filings from the CNMI); therefore, this information may be the only way to verify an individual’s unique identity.

**12. Provide estimates of the hour burden of the collection of information. The statement should:**

\* This Average Hourly Wage Rate is the May 2019 Bureau of Labor Statistics average wage for Business and Financial Operations Occupations of \$37.56 times the wage rate benefit multiplier of 1.46 (to account for benefits provided) equaling \$54.84.

\*\* This is the estimated maximum number of Named Worker Attachments for Form I-129H2A that could be submitted if each named worker petition included the maximum 25 beneficiaries allowed, which would require 24 Named Worker Attachments to be submitted per petition.

**13. Provide an estimate of the total annual cost burden to respondents or record keepers resulting from the collection of information. (Do not include the cost of any hour burden shown in Items 12 and 14).**

- **The cost estimate should be split into two components: (a) a total capital and start-up cost component (annualized over its expected useful life); and (b) a total operation and maintenance and purchase of services component. The estimates should take into account costs associated with generating, maintaining, and disclosing or providing the information. Include descriptions of methods used to estimate major cost factors including system and technology acquisition, expected useful life of capital equipment, the discount rate(s), and the time period over which costs will be incurred. Capital and start-up costs include,**

among other items, preparations for collecting information such as purchasing computers and software; monitoring, sampling, drilling and testing equipment; and record storage facilities.

There are no start-up, maintenance, and operating costs associated with this collection of information. For informational purposes, there is fee of \$850 collected for Form I-129H2A petitions with named beneficiaries and a \$415 fee collected for Form I-129H2A petitions with unnamed beneficiaries.

This information collection may impose some out-of-pocket costs on respondents in addition to the time burden for the form's preparation.

For form preparation, legal services, translators, and document search and generation, USCIS estimates the average cost of this information collection may vary widely, from as little as \$20 to \$1000 per respondent. USCIS estimates that the average cost for these activities is \$515. The total cost to respondents would generate as follows: 12,008 estimated respondents multiplied by the average cost per response of \$515 = **\$6,184,120.00.**

- 14. Provide estimates of annualized cost to the Federal government. Also, provide a description of the method used to estimate cost, which should include quantification of hours, operational expenses (such as equipment, overhead, printing, and support staff), and any other expense that would not have been incurred without this collection of information. #### **Government Cost**

USCIS establishes its fees using an activity-based costing model to assign costs to an adjudication based on its relative adjudication burden and use of USCIS resources. Fees are established at an amount that is necessary to recover these assigned costs, plus an

amount to recover unassigned overhead (which includes the clerical, officer, and managerial time with benefits) and immigration benefits provided for free. As a consequence of USCIS immigration fees being based on resource expenditures related to the benefit in question, USCIS uses the fee associated with an information collection as a reasonable measure of the collection's costs to USCIS. USCIS has established the fee for H2A based on whether the petition is for named or unnamed beneficiaries. The fee for Form I-129H2A with named beneficiaries is \$850 (up to 25 named beneficiaries may be included on one Form I-129H2A). The fee for Form I-129H2A with unnamed beneficiaries is \$415.

The total estimated cost of the program to USCIS is calculated by multiplying the estimated number of respondents for Form I-129H2A with named beneficiaries (2,740) by the fee charge (\$850), which equals \$2,329,000. This calculation is repeated for the estimated number of respondents for Form I-129H2A with unnamed beneficiaries (9,268 multiplied by \$415 equals \$3,846,220). These sums are added together for a total cost to USCIS of **\$6,175,220**. This total includes the suggested average hourly rate for clerical, officer, and supervisory time with benefits, plus a percent for the estimated overhead cost for printing, stocking, and distributing this form.

**15. Explain the reasons for any program changes or adjustments reporting in Items 13 or 14 of the OMB Form 83-I.**

The original Form I-129 has been separated into several different forms covering different nonimmigrant employment visa classifications. Form I-129H2A is filed by petitioners seeking to employ nonimmigrants under the H-2A classification.

This information collection will not be published for statistical purposes.

USCIS will display the expiration date for OMB approval of this information collection.

USCIS does not request an exception to the certification of this information collection.

**B. Collections of Information Employing Statistical Methods.**



There is no statistical methodology involved with this collection.
