

SUPPORTING STATEMENT
FOR PAPERWORK REDUCTION ACT SUBMISSION

Under the current unprecedented national health emergency, Congress and the President have come together to offer relief to those individuals and industries affected by the COVID-19 virus under the Coronavirus Aid, Relief, and Economic Security Act or the CARES Act.

In the CARES Act, Congress provided authority under the Historically Black College and University (HBCU) Capital Financing Program for deferments due to a qualifying emergency. Generally, the CARES Act provides that the Secretary may grant a deferment to recipients of Program loans, regardless of whether the recipient is a public or private HBCU, for the duration of the coronavirus-related emergency. The Department has developed an application for HBCUs to seek a deferment of a Program loan under the CARES Act. We are requesting an extension of the approval for this collection (1840-0845), which is currently approved through 12/31/2020 under emergency processing.

This application will allow a Program participant to request the deferment and submit information for the Department's required report to Congress regarding its use of its CARES Act authority to grant the deferments.

Data collection will be conducted electronically. Applications will be submitted via email.

This information is not duplicated in any other information collection.

Due to the minimal burden required to complete this collection, the Department does not believe the requirements will adversely impact any institution that may meet the small entity designation.

If this collection is not allowed to proceed, the Department will not be able to fulfill the mandates of the CARES Act, and institutions and their students will not be able to receive the financial assistance authorized under this law.

Due to the CARES Act, the Department previously received emergency approval from OMB for this collection. In an effort to comply with the Paperwork Reduction Act, the Department published a 60 day notice for public comment but did not receive any comments in response to that notice.

A 30 day Federal Register notice for public comment will be published as required. The Department will respond to comments received as a result of that notice.
