### A. JUSTIFICATION:

## **1.** Explain the circumstances that make the collection of information necessary. Identify legal or administrative requirements that necessitate the collection of information.

The Department of Veterans Affairs (VA) through its Veterans Benefits Administration (VBA) administers an integrated program of benefits and services, established by law, for veterans, service personnel, and their dependents and/or beneficiaries. Under the authority of; Title 38 U.S.C. 501 *Rules and Regulations*, Title 38 U.S.C. 5103 *Due Process*, Title 38 U.S.C. 5101(a) *Claims and Forms*, and Title 38 Code of Federal Regulations (C.F.R.) 3.159 *Duty to Assist* and Title 38 C.F.R. 3.303 *Principles of Service Connection*, VA Form 21-10210, *Lay/Witness Statement*, allows lay or witness statements to be used as evidence that is competent if it is provided by a person who has knowledge of facts or circumstances and conveys matters that can be observed and described by a lay person. VBA does not have a standard form for claimants to submit a lay or witness statement to support a claim of benefits/services.

The burden has not changed, this is an extension only.

## 2. Indicate how, by whom, and for what purposes the information is to be used; indicate actual use the agency has made of the information received from current collection.

**VA Form 21-10210** is used by the claimant to gather lay or witness statements that support an existing claim for benefits/services. Without this information, VA may not be able to efficiently and successfully process claims that may require additional statements associated with a claim for benefits/services.

Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g. permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration of using information technology to reduce burden.

**VA Form 21-10210** is available on the VA Website in a fillable electronic format. VBA hosts this form on a secure server and does not currently have the technology in place to allow for the complete submission of the forms. Validation edits are performed to assure data integrity. There currently is no utility process in place that will allow the data submitted on the forms to be incorporated with an existing centralized legacy database.

# 4. Describe efforts to identify duplication. Show specifically why any similar information already available cannot be used or modified for use for the purposes described in Item 2 above.

Program reviews were conducted to identify potential areas of duplication; however, none were found to exist. There is no known Department or Agency which maintains the necessary information, nor is it available from other sources within our Department.

The collection of information does not involve small businesses or entities.

**VA Form 21-10210** is used by the claimant to gather lay or witness statements that support an existing claim for benefits/services. Without this information, VA may not be able to efficiently and successfully process claims that may require additional statements associated with a claim for benefits/services.

The Department notice was published in the Federal Register on September 11, 2020, Volume 85, No. 177, pages 56290 and 56291. Two comments were received in response to this notice.

VBA received comment (1) from a Ms. Diane Rauber, Executive Director, with National Organization of Veterans' Advocates (NOVA). See the supplemental document, titled '2900-0881, Comment-Response (NOVA)', attached to this ICR for the comment and VBA's response.

VBA received comment (2) from a Mr. B. Hazell, with the Veterans of Foreign Wars of the United States (VFW). As Mr. Hazell didn't specifically ask a question regarding the form itself, other than to explain why VFW cannot support the form usage, VBA is not required to respond.

## 9. Explain any decision to provide any payment or gift to respondents, other than remuneration of contractors or grantees.

No payments or gifts to respondents have been made under this collection of information.

## 10. Describe any assurance of privacy to the extent permitted by law provided to respondents and the basis for the assurance in statute, regulation, or agency policy.

The records are maintained in the appropriate Privacy Act System of Records identified as "Compensation, Pension, Education, and Vocational Rehabilitation and Employment Records-VA (58VA21/22/28)," published at 74 FR 29275 on June 19, 2009, and last amended at 84 FR 4138 (February 14, 2019).

11. Provide additional justification for any questions of a sensitive nature (Information that, with a reasonable degree of medical certainty, is likely to have a serious adverse effect on an individual's mental or physical health if revealed to him or her), such as sexual behavior and attitudes, religious beliefs, and other matters that are commonly considered private; include specific uses to be made of the information, the explanation to be given to persons from whom the information is requested, and any steps to be taken to obtain their consent.

There are no questions of a sensitive nature.

### 12. Estimate of the hour burden of the collection of information:

- a. Total Number of Respondents is estimated at **<u>100,000</u>** per year.
- b. Frequency of Response is one time.
- c. Total Annual burden hours is estimated at **<u>16,667</u>** hours.
- d. Average estimated completion time is **<u>10</u>** minutes.
- e.The respondent population for **VA Form 21-10210** is composed of individuals who are submitting lay or witness statements to support claims for benefits or services. VA cannot make further assumptions about the population of respondents because

of the variability of factors such as the educational background and wage potential of respondents. Therefore, VBA used general wage data to estimate the respondents' costs associated with completing the information collection.

The Bureau of Labor Statistics (BLS) gathers information on full-time wage and salary workers. According to the latest available BLS data, the mean hourly wage is \$25.72 based on the BLS wage code – "00-0000 All Occupations." This information was taken from the following website: <u>https://www.bls.gov/oes/current/oes\_nat.htm</u>.

Legally, respondents may not pay a person or business for assistance in completing the information collection. Therefore, there are no expected overhead costs for completing the information collection. VBA estimates the total cost to all respondents to be \$428,675.24 (16,667 burden hours x \$25.72 per hour).

This submission does not involve any recordkeeping costs.
