**A. Justification**

CBP Form 255, Declaration of Unaccompanied Articles, is completed by travelers arriving in the United States with a parcel or container which is to be sent from an insular possession at a later date. It is the only means whereby the CBP officer, when the person arrives, can apply the exemptions or 5 percent flat rate of duty to all of the traveler's purchases.

CBP Form 255 is authorized by 19 U.S.C. 1202 (Chapter 98, Subchapters IV and XVI) and provided for by 19 CFR 145.12, 145.43, 148.110, 148.113, 148.114, 148.115 and 148.116. A sample of this form can be viewed at <https://www.cbp.gov/newsroom/publications/forms?title=255&=Apply#>

- 2. Indicate how, by whom, and for what purpose the information is to be used. Except for a new collection, indicate the actual use the agency has made of the information received from the current collection.**

CBP uses this form to ensure that mailed articles are accorded the appropriate duty exemption and to ensure the safety and security of those operating the conveyance.

CBP Form 255 is completed by respondents while they are in-transit on conveyances such as airplanes. Also, this form is presented to the CBP officer at the port of arrival for verification and signature, and a copy is sent to the vendor who affixes it to the package, so it would be difficult to automate this process.

This information is not duplicated elsewhere.

This information collection does not have an impact on small businesses or other small entities.

If this information were conducted less frequently, the traveling public would not receive the personal duty exemptions and CBP might not be aware if there were a potentially dangerous item being transported.

This information is collected in a manner consistent with the guidelines of 5 CFR 1320.5(d)(2).

Public comments were solicited through two Federal Register notices including a 60-day notice published on August 18, 2020 (Volume 85, Page 50831) on which no comments were received, and a 30-day notice published on October 22, 2020 (Volume 85, Page 67364) on which no comments have been received.

There is no offer of a monetary or material value for this information collection.

### Public Cost

The estimated cost to the respondents is \$58,875. This is based on the estimated burden hours (1,250) multiplied by the average hourly wage rate for all-purpose air travelers (\$47.10). CBP used the U.S. Department of Transportation's (DOT) recommended hourly value of travel time savings for intercity, all purpose travel by air and high speed rail, which is provided in 2015 U.S. dollars. CBP assumes an annual growth rate of 0 percent; the 2015 U.S. dollar value is equal to the 2020 U.S. dollar value.<sup>1</sup>

- 13. Provide an estimate of the total annual cost burden to respondents or record keepers resulting from the collection of information.**

There are no record keeping, capital, start-up or maintenance costs associated with this information collection

**include quantification of hours, operational expenses (such as equipment overhead, printing, and support staff), and any other expense that would not have been incurred without this collection of information.**

The estimated annual cost to the Federal Government associated with the review of these records is \$225,475. This is based on the number of responses that must be reviewed (15,000) multiplied by the time burden to review and process each response (5 minutes or .1667 hours) = 2,500 hours multiplied by the average hourly loaded rate for a Supervisory CBP Officer ( $\$90.19$ )<sup>2</sup> = \$225,475.

There has been no increase or decrease in the estimated annual burden hours previously reported for this information collection. There are no changes to the information being collected.
