Petition for Alien Relative

A citizen or lawful permanent resident of the United States may file Petition for Alien Relative (I-130), with U.S. Citizenship and Immigration Services (USCIS) to establish the existence of a relationship to certain alien relatives who wish to immigrate to the United States.

Filing the I-130 is only the first step in helping a relative immigrate to the United States. Eligible family members must wait until there is a visa number available before they can apply to become a lawful permanent resident. If, at that time, your relative is present in the United States, they can apply for lawful permanent resident status through a process called <u>Adjustment of Status</u>. However, if your relative is outside of the United States, they must complete <u>consular processing</u> with the U.S. Department of State at an embassy or consulate to first get an immigrant visa and travel to the United states to be admitted as a lawful permanent resident.
