**A.JUSTIFICATION:**

- 1. Explain the circumstances that make the collection of information necessary. Identify legal or administrative requirements that necessitate the collection of information.**

The Department of Veterans Affairs (VA), through its Veterans Benefits Administration (VBA), administers an integrated program of benefits and services, established by law, for Veterans, service personnel, and their survivors. As a part of the implementation of the Appeals Modernization Act, VA created the new Supplemental Claim process, along with the appropriate form for submitting a Supplemental Claim; VA Form 20-0995, *Decision Review Request: Supplemental Claim*. Information is requested by this form to formalize a request for a Supplemental Claim on a decision rendered by VA. In addition to providing VA with the identity of the claimant, the Supplemental Claim Form indicates the specific issues that the claimant disagrees with, and the form identifies any new and relevant evidence that supports a supplemental claim. Authority is found in P. L. 115-55, and 38 C.F.R. § 3.2501.

This is a request for a new control number. VA Form 20-0995 was previously approved under control number 2900-0862. It has been separated from this control group so a new control number can be assigned. No changes are being made to the form.

- 2. Indicate how, by whom, and for what purposes the information is to be used; indicate actual use the agency has made of the information received from current collection.**

VA Form 20-0995, *Decision Review Request: Supplemental Claim*, will be used by a claimant and/or beneficiary to formally request a review of an initial VA decision, based on new and relevant evidence, in accordance with the Appeals Modernization Act.

The information collected will be used by VA to identify the issues in dispute which the claimant seeks review of in the Supplemental Claim Lane.

Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g., permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration of using information technology to reduce burden.**

VA Form 20-0995 will be available on the One-VA Website in a fillable electronic format. VBA is currently hosting this form on a secure server and does not currently have the technology in place to allow for the complete submission of the form. Validation edits are performed to assure data integrity. There currently is no utility process in place that will allow the data submitted on the form to be incorporated with an existing centralized legacy database.

Program reviews were conducted to identify potential areas of duplication; however, none were found to exist. There is no known Department or Agency which maintains the necessary information, nor is it available from other sources within our Department.

The collection of information does not involve small businesses or entities.

VA Form 20-0995 will be used by a claimant and/or beneficiary to formally request a review of an initial VA decision, based on new and relevant evidence, in accordance with the Appeals Modernization Act.

VA Form 20-0995 will be used by a claimant to formally request a review of an initial VA decision, based on new and relevant evidence, in accordance with the Appeals Modernization Act. Without the information solicited by this form, VA would be unable to initiate the Supplemental Claim on behalf of the claimant or determine the issues for which the claimant seeks review.

The frequency of collection depends solely upon the desire of VA claimants to seek review of an initial VA decision in the Supplemental Claim Lane. In that sense, VA does not control the frequency of collection.

No payments or gifts to respondents have been made under this collection of information.

**10. Describe any assurance of privacy to the extent permitted by law provided to respondents and the basis for the assurance in statute, regulation, or agency policy.**

The records are maintained in the appropriate Privacy Act System of Records identified as “Compensation, Pension, Education, and Vocational Rehabilitation and Employment Records-VA (58VA21/22/28),” published at 74 FR 29275 on June 19, 2009, and last amended at 84 FR 4138 (February 14, 2019).

**11. There are no questions of a sensitive nature.

**12. Estimate of the hour burden of the collection of information:**

a.Number of Respondents is estimated at 265,000 per year.

b.Frequency of Response is one time.

c.Annual burden hours are 66,250 hours. (265,000 x 15/60)

d.The estimated completion time for each form is 15 minutes.

e.The respondent population for VA Form 20-0995 is composed of individuals who are requesting a Decision Review Request: Supplemental Claim to formally request a review of an initial VA decision. VA cannot make further assumptions about the population of respondents because of the variability of factors such as the educational background and wage potential of respondents. Therefore, VBA used general wage data to estimate the respondents’ costs associated with completing the information collection.

The Bureau of Labor Statistics (BLS) gathers information on full-time wage and salary workers. According to the latest available BLS data, the mean hourly wage is \$25.72

based on the BLS wage code – “00-0000 All Occupations.” This information was taken from the following website: [https://www.bls.gov/oes/current/oes\\_nat.htm](https://www.bls.gov/oes/current/oes_nat.htm).

Legally, respondents may not pay a person or business for assistance in completing the information collection. Therefore, there are no expected overhead costs for completing the information collection. VBA estimates the total cost to all respondents to be \$6,815,800 (265,000 burden hours x \$25.72 per hour).

This submission does not involve any recordkeeping costs.
