Only the most frequently involved GS grade is listed if a portion of the information is processed by different GS grade levels. i.e. Some records disclosing live dogs and cats acquisitions and dispositions are evaluated by ACIs at GS 9 and some by VMOs at GS 12. It is not efficient or effective to separate the number records evaluated by the ACIs or VMOs.
