**Minor Revisions to the Collection Instruments**

SSA is making the following revisions:

- **Change #1:** On page two section 2, we are changing the fee for the Itemized Statement of Earnings.

**from:** \$91.00  
**to:** \$92.00

**Justification #1:** The fees for this form have changed.

- **Change #2:** On page two section 2, we are changing the fee for the Certified Yearly Totals of Earnings.

**from:** \$34.00  
**to:** \$64.00

**Justification #2:** The fees for this form have changed.

- **Change #3:** On page three, under “Is There A Fee For Earnings Information”, we are changing the line that says we charge a \$91.00 fee.

**from:** Yes. We charge a \$91.00 fee  
**to:** Yes. We charge a \$92.00 fee

**Justification #3:** The fees for this form have changed.

- **Change #4:** On page three, under “Certified or Non-Certified Itemized Statement of Earnings”, we are changing the first sentence in paragraph two.

**from:** We will certify the itemized earnings information for an additional \$34.00 fee  
**to:** We will certify the itemized earnings information for an additional \$64.00 fee

**Justification #4:** The fees for this form have changed.

- **Change #5:** On page three, under “Certified Yearly totals of Earnings”, we are changing the line that says we charge \$34 to certify yearly totals.

**from:** We charge \$34 to certify yearly totals of earnings  
**to:** We charge \$64 to certify yearly totals of earnings

**Justification #5:** The fees for this form have changed.

- **Change #6:** On page four, under “How much do I have to pay for an Itemized Statement of Earnings?”, we are changing the Non-Certified Itemized Statement of Earnings fee.

**from:** \$91.00  
**to:** \$92.00

**Justification #6:** The fees for this form have changed.

- **Change #7:** On page four, under “How much do I have to pay for an itemized Statement of Earnings?”, we are changing the Certified Itemized Statement of Earnings fee.

**from:** \$125.00  
**to:** \$156.00

**Justification #7:** The fees for this form have changed.

- **Change #8:** On page four, under “How much do I have to pay for Certified yearly totals of Earnings?”, we are changing the Certified yearly totals of earnings cost .

**from:** \$34.00  
**to:** \$64.00

**Justification #8:** The fees for this form has changed.

- **Change #9:** On page four, under “You can make your payment by credit card?”, we are changing the fees in the amount charged field.

**from:** \$34.00, \$91.00, or \$125.00  
**to:** \$64.00, \$92.00, or \$156.00

**Justification #9:** The fees for this form has changed.

- **Change #10:** We are revising the PRA statement on this form.

**Justification #10:** We are revising the PRA statement to reflect our current boilerplate language. The current language, which dates back to the last reprint of the form, is now outdated.

- **Change #11:** We are revising the Privacy Act Statement on this form.

**Justification #11:** SSA’s Office of the General Counsel is conducting a systematic review of SSA’s Privacy Act Statements on agency forms. As a result, SSA is updating the Privacy Act Statement on the form.

SSA will implement these changes to the SSA-7050 upon OMB approval.
