#### 2.1.2. Initiate Earnings Corrections Privacy Act Statement

#### Privacy Act Statement Collection and Use of Personal Information

Sections 205(a), (c)(2), (4), (5), and 233 of the Social Security Act, as amended, allow us to collect this information. Furnishing us this information is voluntary. However, failing to provide all or part of the information may affect the accuracy of your earnings record.

We will use the information to correct your earnings record. We may also share your information for the following purposes, called routine uses:

- 1. To employers or former employers, including State Social Security administrators, for correcting and reconstructing State employee earnings records and for Social Security purposes.
- 2. To officers and employees of Federal, State or local agencies upon written request in accordance with the Internal Revenue Code (IRC) U.S.C. 6103(I)(7)), tax return information (e.g., information with respect to net earnings from self-employment, wages, payments of retirement income which have been disclosed to the Social Security Administration, and business and employment addresses) for purposes of, and to the extent necessary in, determining an individual's eligibility for, or the correct amount of, benefits under certain programs listed in the IRC.

In addition, we may share this information in accordance with the Privacy Act and other Federal laws. For example, where authorized, we may use and disclose this information in computer matching programs, in which our records are compared with other records to establish or verify a person's eligibility for Federal benefit programs and for repayment of incorrect or delinquent debts under these programs.

#### ▲ Limits on Taxable Earnings for Social Security

There's a limit on the amount of earnings on which you pay Social Security taxes each year. The limit usually increases yearly. Earnings above the limit will not appear on your earnings chart as Social Security earnings. (For Medicare taxes, the maximum earnings amount began rising in 1991. Since 1994, all of your earnings are taxed for Medicare.)

Note: Currently, you and your employer each pay a 6.2 percent Social Security tax on up to \$137,700 of your earnings and a 1.45 percent Medicare tax on all your earnings. If you are selfemployed, you pay the combined employee and employer amount, which is a 12.4 percent Social Security tax on up to \$137,700 of your net earnings and a 2.9 percent Medicare tax on your entire net earnings. If you have earned income of more than \$200,000 (\$250,000 for married couples filing jointly), you must pay 0.9 percent more in Medicare taxes.

#### ▲ Why would earnings be missing from my record?

If the earnings missing from your Social Security record are for the current year or last year, you don't need to worry. Because these earnings are recent, we may not have recorded them yet. They should appear on a later Statement.

However, earnings could be missing from your record for earlier years for one of the following reasons:

- · Your employer reported your earnings using the wrong name or Social Security number.
- · Your employer reported your earnings incorrectly.
- · You got married or divorced and changed your name, but never reported the change to Social Security.
- · You worked using a Social Security number that didn't belong to you.
