#### OMB CLEARANCE: SUMMARIZED DISCUSSION OF FORM REVISIONS

As discussed at the April 10<sup>th</sup> meeting with OCS, NASCSP and OCS will put forward only technical changes to Modules 1-4 of the CSBG Annual Report for inclusion in an OMB Clearance package. 
