**A. JUSTIFICATION:**

**1. Explain the circumstances that make the collection of information necessary. Identify legal or administrative requirements that necessitate the collection of information.**

The Department of Veterans Affairs (VA) through its Veterans Benefits Administration (VBA) administers an integrated program of benefits and services, established by law, for Veterans, service personnel, and their dependents and/or beneficiaries. Title 38 U.S.C. 5101(a) provides that a specific claim in the form provided by the Secretary must be filed for benefits to be paid or furnished to any individual under the laws administered by the Secretary. VA Form (VAF) 28-8832, Personalized Career Planning and Guidance Application, collects information that the Veteran Readiness and Employment (VR&E) and Office of Transition and Economic Development (OTED) need to quickly assess the applicant's probable eligibility to educational and vocational counseling, now referred to as Personalized Career Planning and Guidance (PCPG) benefits, under 38 U.S.C. 3697A. In accordance with 38 U.S.C. 501(a), the Secretary shall obtain information sufficient to establish the right to benefits.

VAF 28-8832 has been updated, to include:

- A new title as the name of the program has been changed to Personalized Career Planning and Guidance (PCPG). The current title of VAF 28-8832 is "Educational/Vocational Counseling Application". However, the title has been revised to "Personalized Career Planning and Guidance Application".
- Opt-in language for use of the claimant's email. This is a non-substantive change.
- Reference to "Vocational Rehabilitation and Employment" (VR&E) has been revised to "Veteran Readiness and Employment" (VR&E). This is a non-substantive change.
- Electronic-signature capabilities. This is a non-substantive change.
- The respondent burden has decreased from 30 minutes to 15 minutes.

Note: Due to an influx in staffing resources our Program Office is now requesting to have this collection reinstated with only the non-substantive changes listed above.

**2. Indicate how, by whom, and for what purposes the information is to be used; indicate actual use the agency has made of the information received from current collection.**

A Veteran, Service member, or dependent may use VAF 28-8832 to apply for PCPG benefits. The information on the form is used by program staff to determine if a claimant is eligible to PCPG benefits. Without the structured questions provided on the form, the application process could be delayed, particularly in instances where incomplete information is submitted.

- 3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g. permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration of using information technology to reduce burden.**

VA Form 28-8832 is available on the One-VA Website in a fillable electronic format. VBA is currently hosting this form on a secure server and does not currently have the technology in place to allow for the complete submission of the form. Validation edits are performed to assure data integrity. There currently is no utility process in place that will allow the data submitted on the form to be incorporated with an existing centralized legacy database.

- 4. Describe efforts to identify duplication. Show specifically why any similar information already available cannot be used or modified for use for the purposes described in Item 2 above.**

Program reviews were conducted to identify potential areas of duplication; however, none were found to exist. There is no known Department or Agency which maintains the necessary information, nor is it available from other sources within our Department.

- 5. If the collection of information impacts small businesses or other small entities, describe any methods used to minimize burden.**

The collection of information does not involve small businesses or entities.

A Veteran, Service member, or dependent may use VAF 28-8832 to apply for PCPG benefits and the information on the form assists program staff to determine a claimant's eligibility to PCPG benefits. Without the structured questions on this form, the application process could be delayed, particularly in instances where incomplete data is submitted.

The Department notice was published in the Federal Register on February 16, 2021, Vol. 86, No. 29, page 9572. No comments were received.

The records are maintained in the appropriate Privacy Act System of Records identified as "Compensation, Pension, Education, and Vocational Rehabilitation and Employment Records-VA (58VA21/22/28)," published at 74 FR 29275 on June 19, 2009, and last amended at 84 FR 4138 (February 14, 2019).

- 11. Provide additional justification for any questions of a sensitive nature (Information that, with a reasonable degree of medical certainty, is likely to have a serious adverse effect on an individual's mental or physical health if revealed to him or her), such as sexual behavior and attitudes, religious beliefs, and other matters that are commonly considered private; include specific uses to be made of the information, the explanation to be given to persons from whom the information is requested, and any steps to be taken to obtain their consent.**

There are no questions of a sensitive nature.

- 12. Estimate of the hour burden of the collection of information:**

- a. Number of Respondents is estimated at 11,000 per year.
- b. Frequency of Response is one time.
- c. Annual burden hours are 2,750 hours.
- d. The estimated completion time for each form is 15 minutes.

e. The respondent population for VA Form 28-8832 is composed of Veterans, Service members, and dependents who are applying for educational and vocational counseling, referred to as PCPG benefits, under 38 U.S.C. 3697A. VA cannot make further assumptions about the population of respondents because of the variability of factors such as the educational background and wage potential of respondents. Therefore, VBA used general wage data to estimate the respondents' costs associated with completing the information collection.

The Bureau of Labor Statistics (BLS) gathers information on full-time wage and salary workers. According to the latest available BLS data, the mean hourly wage is \$27.07 based on the BLS wage code – “00-0000 All Occupations.” This information was taken from the following website: [https://www.bls.gov/oes/current/oes\\_nat.htm](https://www.bls.gov/oes/current/oes_nat.htm).

Legally, respondents may not pay a person or business for assistance in completing the information collection. Therefore, there are no expected overhead costs for completing the information collection. VBA estimates the total cost to all respondents to be \$74,442.50 (2,750 burden hours x \$27.07 per hour).

This submission does not involve any recordkeeping costs.

Overhead costs are 100% of salary and are the same as the wage listed above and the amounts are included in the total.

Printing and production costs approximates the cost of printing this information collection per year. (Processing/Analyzing Cost total divided by \$90).

This rate does not include any locality adjustment as applicable.

The processing time estimates above are based on the actual amount of time employees of each grade level spend to process to completion a claim received on this form. The within-grade step (3) of each employee represents the average experience of employees within each grade.

**15. Explain the reason for any burden hour changes since the last submission.**

The respondent burden has decreased from 30 minutes to 15 minutes. While the length of the form and the questions asked has not changed, a review of the question content was completed. It is estimated that 15 minutes is a more realistic estimate considering the ease to which most claimants should be able to access the requested information.
