**TITLE OF INFORMATION COLLECTION:** NLM NCBI 2018 Microbial Genome Resources Survey

**PURPOSE:**

The goal of this National Library of Medicine (NLM) survey is to collect qualitative customer service delivery feedback from users of the National Center for Biotechnology Information (NCBI) molecular resources that focus on bacteria, specifically, customers who view bacterial records using the Assembly, Nucleotide, Genome, BLAST, and Protein resources. The information from this survey will be used to improve the content and scope of the public data and resources for bacteria.
