**TITLE OF INFORMATION COLLECTION:** Survey to Assess the Quality of Grant Review and Study Section Structure Among NIH Center for Scientific Review (CSR) Reviewers

**PURPOSE:** NIH depends on CSRs’ peer review process to ensure that all NIH grant applications receive fair, independent, expert, and timely reviews that are free from inappropriate influences. To help assess and maintain the quality and efficiency of peer review at CSR, NIH has developed a new process that includes, among other measures, surveys to hear reviewers’ opinions about the quality of the review in which they participated in. Moreover, CSR is constantly evaluating the structure of their study sections to ensure that grant applications are balanced across study sections in terms of workload and scientific impact. The survey will help assess if the review panel had the appropriate expertise, if the grant applications were assigned to reviewers with appropriate expertise, and if the scientific scope of the study section was appropriate. Feedback from reviewers will help CSR identify areas of success and room for improvements in the CSR review process. This collection is part of a larger and ongoing effort that includes the review of both secondary and primary research and evaluation activities as well as committees made of external experts from the scientific community and internal leaders from CSR and across NIH.

**DESCRIPTION OF RESPONDENTS:** Respondents will be approximately 400 NIH CSR grant reviewers serving on review meetings for the January 2020 Council. Most of these individuals are research scientists who work at academic universities across the U.S.
