Below is the list of EIS Core Activities of Learning, or CALs, which EIS officers must complete over the course of the fellowship.

EIS Core Activities of Learning (CALs):

- CAL 1: Conduct or participate in a field investigation of a potentially serious public health problem that requires a timely response
- CAL 2: Design, conduct, and interpret an epidemiologic analysis
- CAL 3: Evaluate a public health surveillance system
- CAL 4: Give an in-depth public health talk on the officer's original work or in their field of study
- CAL 5: Give a 5–15 minute oral presentation to a scientific audience
- CAL 6: Write a scientific manuscript for a peer-reviewed journal
- CAL 7: Write a concise public health update communicating timely information
- CAL 8: Write a scientific abstract
- CAL 9: Communicate complex scientific concepts to a lay audience
- CAL 10: Provide service to the agency (health department or CDC)
