



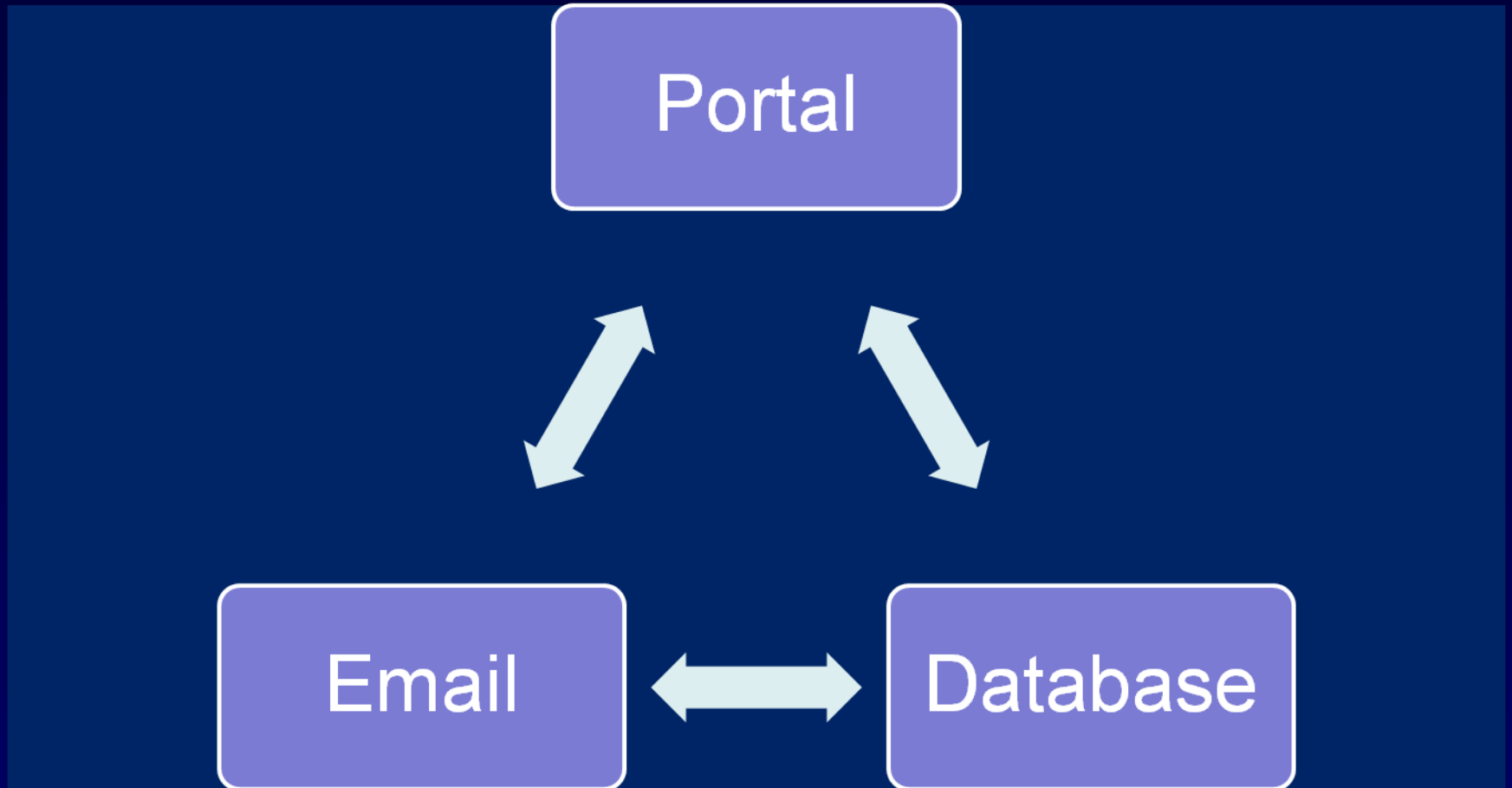

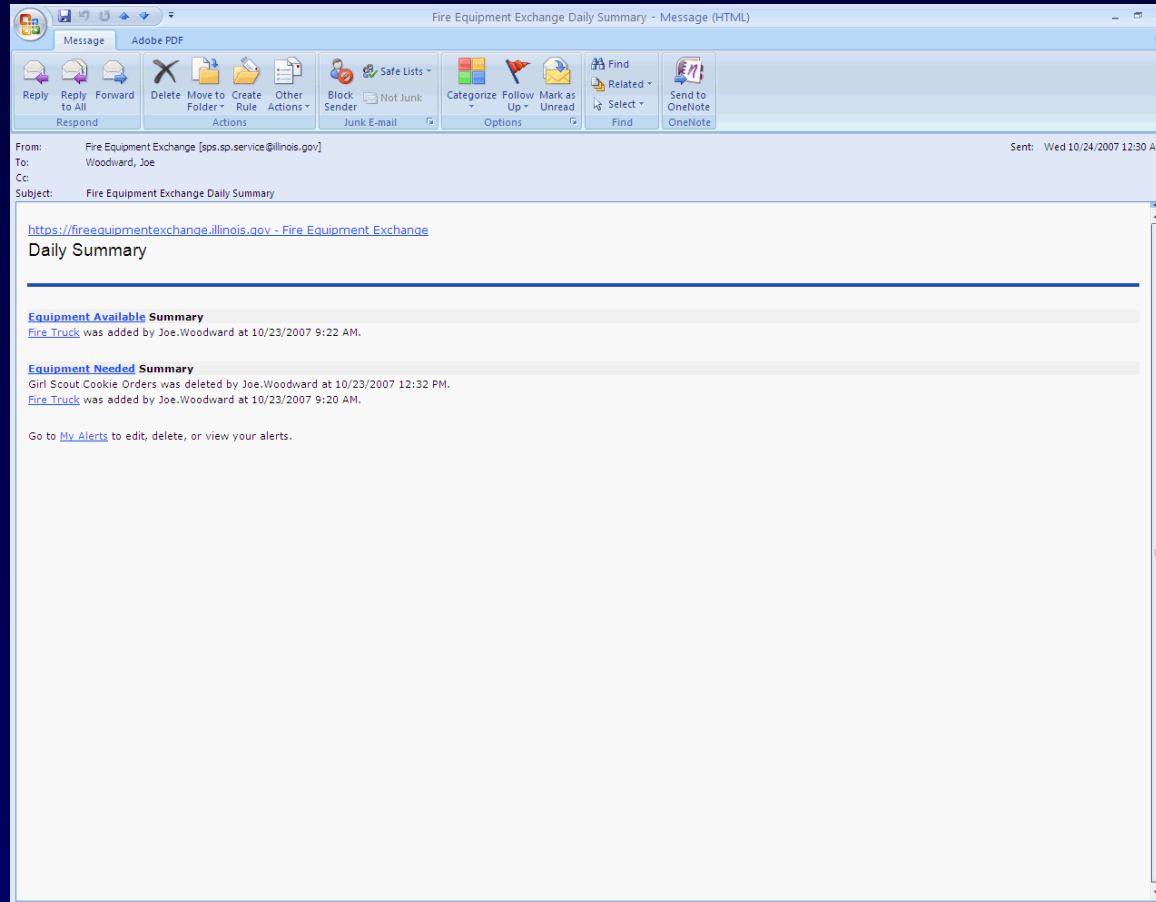

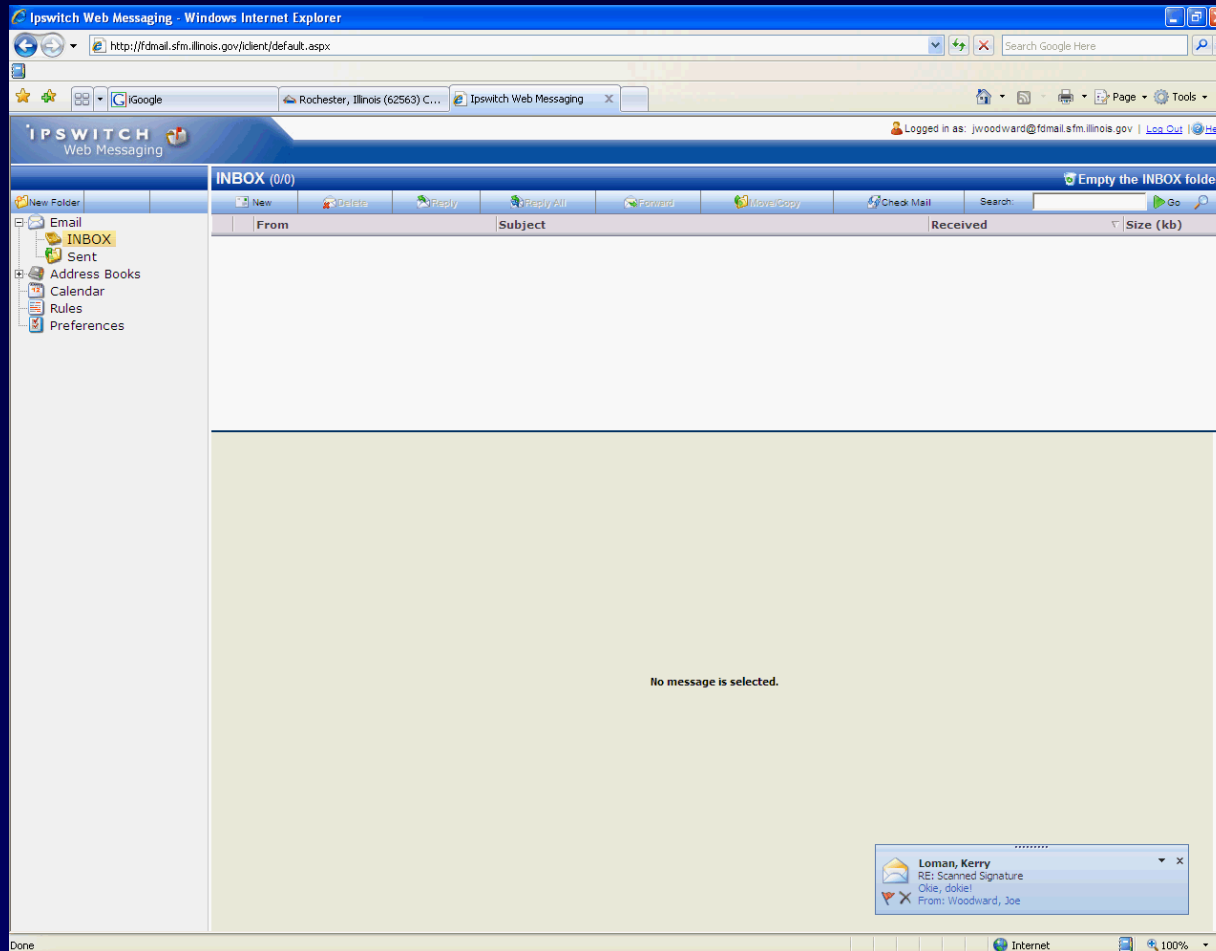


Internet E-mail Accounts for Fire Departments
