

SUPPORTING STATEMENT
FOR PAPERWORK REDUCTION ACT SUBMISSION

Under the current unprecedented national health emergency, Congress and the President have come together to offer relief to those individuals and industries affected by the COVID-19 virus under the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA) (P.L. 116-260). Section 314(a)(4) of the CRRSAA authorizes the Secretary of Education to allocate formula grant funds to proprietary institutions of higher education (IHEs) to make financial aid grants directly to students, which may be used for any component of the student's cost of attendance or for emergency costs that arise due to coronavirus, such as tuition, food, housing, health care (including mental health care) or child care.

This collection is currently approved under emergency processing; we are now requesting an extension of the approved collection under regular processing.

The information will be used by the Department to process grant awards to eligible IHEs under the CRRSAA.

Data collection will be conducted electronically.

This information is not duplicated in any other information collection.

The Department does not believe the requirements will adversely impact any institution that may meet the small entity designation.

If this collection is not allowed to proceed, the Department will not be able to fulfill the mandates of the CRRSAA, and students will not be able to receive the financial assistance authorized by Congress and signed into law by the President.

This information collection does not require any special circumstances.

The Department previously received emergency approval from OMB for this collection. In an effort to comply with the Paperwork Reduction Act, the Department published a 60 day notice for public comment on January 15, 2021. No comments were submitted.

A 30 day Federal Register notice for public comment will be published as required. The Department will respond to comments received as a result of that notice.

We estimate that it will take 1,757 respondents 8,785 total hours to complete and submit the required forms, which includes time for completion and submission of the certification and agreement, as well as subsequent reporting in accordance with CRRSAA requirements.
