

SUPPORTING STATEMENT  
FOR PAPERWORK REDUCTION ACT SUBMISSION

**1. Explain the circumstances that make the collection of information necessary. What is the purpose for this information collection? Under the current unprecedented national health emergency, Congress and the President have come together to offer relief to those individuals and industries affected by the COVID-19 virus under the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA).

Section 314(a)(3) of CRRSAA allocates funds for institutions of higher education that the Secretary determines have the greatest unmet needs related to the coronavirus. This collection includes 1) a certification and agreement and 2) a profile form that will be used by institutions applying for discretionary grant funding under this section. This is a new collection submitted for emergency processing.

This information will be used to select recipients of discretionary grant funding under section 314 (a)(3).

Data collection will be conducted electronically.

This information is not duplicated in any other information collection.

The Department does not believe the requirements will adversely impact any institution that may meet the small entity designation.

If this collection is not allowed to proceed, the Department will not be able to fulfill the mandates of CRRSAA, and institutions will not be able to receive the financial assistance authorized under this law.

- **requiring respondents to report information to the agency more often than quarterly;**
- **requiring respondents to prepare a written response to a collection of information in fewer than 30 days after receipt of it;**

- **in connection with a statistical survey, that is not designed to produce valid and reliable results than can be generalized to the universe of study;**

- **that includes a pledge of confidentiality that is not supported by authority established in statute or regulation, that is not supported by disclosure and data security policies that are consistent with the pledge, or that unnecessarily impedes sharing of data with other agencies for compatible confidential use; or**

- **requiring respondents to submit proprietary trade secrets, or other confidential information unless the agency can demonstrate that it has instituted procedures to protect the information's confidentiality to the extent permitted by law.**

This information collection does not require any special circumstances.

The Department is requesting an emergency clearance from OMB by March 23 and will publish an emergency notice with a 30 day comment period as required by 5 CFR 1320.8(d) to solicit public comments on the regular information collection.

No payments or gifts have been provided to respondents.

We estimate that it will take 1,500 respondents 4,500 total hours to complete and submit the required forms.
