A. JUSTIFICATION:

- 1. Explain the circumstances that make the collection of information necessary. Identify legal or administrative requirements that necessitate the collection of information.**

The Department of Veterans Affairs (VA) through its Veterans Benefits Administration (VBA) administers an integrated program of benefits and services, established by law, for Veterans, service personnel, and their dependents and/or beneficiaries. Title 38 U.S.C. 501(a) provides VA the authority to collect this information. VA Form (VAF) 28-1902w, *Veteran Readiness and Employment (VR&E) Questionnaire (Chapter 31, Title 38 U.S. Code)* is used by VA Vocational Rehabilitation Counselors (VRC) to gather the necessary information to determine entitlement during the initial evaluation process. The information is necessary to assist the VRC in during the initial evaluation to make an entitlement determination under 38 U.S.C. 3106.

- 2. Indicate how, by whom, and for what purposes the information is to be used; indicate actual use the agency has made of the information received from current collection.**

A claimant completes VAF 28-1902w to provide information to assist a VRC during the comprehensive initial evaluation in making an entitlement determination to benefits under 38 U.S.C. Chapter 31. VAF 28-1902w is via mailed or emailed to the claimant prior to his or her initial evaluation to allow the claimant ample time to complete prior to the initial evaluation.

Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g. permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration of using information technology to reduce burden.**

VA Form 28-1902w is available on the One-VA Website in a fillable electronic format. VBA is currently hosting this form on a secure server and does not currently have the technology in place to allow for the complete submission of the form. Validation edits are performed to assure data integrity. There currently is no utility process in place that will allow the data submitted on the form to be incorporated with an existing centralized legacy database.

- 4. Describe efforts to identify duplication. Show specifically why any similar information already available cannot be used or modified for use for the purposes described in Item 2 above.**

Program reviews were conducted to identify potential areas of duplication; however, none were found to exist. There is no known Department or Agency which maintains the necessary information, nor is it available from other sources within our Department.

VA Form 28-1902w is used to gather the necessary information to determine entitlement under 38 U.S.C Chapter 31. Without this information, determination of entitlement to the maximum benefit to include counseling, education, and/or rehabilitation program may not be granted under 38 U.S.C. 3102, 38 U.S.C 3106 and 38 U.S.C. 501(a).

The records are maintained in the appropriate Privacy Act System of Records identified as “Compensation, Pension, Education, and Vocational Rehabilitation and Employment Records-VA (58VA21/22/28),” published at 74 FR 29275 on June 19, 2009, and last amended at 84 FR 4138 (February 14, 2019).

There are no questions of a sensitive nature.

12. Estimate of the hour burden of the collection of information:

- a. Number of Respondents is estimated at 126,000 per year.
- b. Frequency of Response is one time.
- c. Annual burden hours are 94,500 hours.
- d. The estimated completion time for each form is 45 minutes.
- e. The respondent population for VA Form 28-1902w is composed of claimants who are applying for benefits to Veteran Readiness and Employment. VA cannot make further assumptions about the population of respondents because of the variability of factors such as the educational background and wage potential of respondents. Therefore, VBA used general wage data to estimate the respondents’ costs associated with completing the information collection.

The Bureau of Labor Statistics (BLS) gathers information on full-time wage and salary workers. According to the latest available BLS data, the mean hourly wage is \$27.07 based on the BLS wage code – “00-0000 All Occupations.” This information was taken from the following website: https://www.bls.gov/oes/current/oes_nat.htm.

Legally, respondents may not pay a person or business for assistance in completing the information collection. Therefore, there are no expected overhead costs for completing the information collection. VBA estimates the total cost to all respondents to be \$852,705 (31,500 burden hours x \$27.07 per hour).

Overhead costs are 100% of salary and are the same as the wage listed above and the amounts are included in the total.

The processing time estimates above are based on the actual amount of time employees of each grade level spend to process to completion a claim received on this form. The within-grade step (3) of each employee represents the average experience of employees within each grade.

The respondent burden has increased. The program has seen a steady influx of claimants applying for benefits since this form was last approved. The increase may be attributed to the following: placement of counselors on military installations and college campuses across the Nation to provide outreach and rehabilitation services to Service members and Veterans; the use of Tele-counseling has allowed for greater access to the program; and the increased use of online marketing to include email, social media and outreach events.
