- 2. Handlers must update their "Total Withholding Obligation" in the Final Withholding Report to reflect any Inter-Handler Transfers between the date the Handler Withholding Plan form is submitted and August 31, 2018.
- 3. All information provided must be supported by valid documentation, including, but not limited to, the following forms that handlers must file with the Committee during the crop year: Grower Acquisition Listings, Whole Fruit Disposal Certification, Processed Fruit Disposal Certification, Inter-Handler Transfer of Withheld Fruit, Notice/Application for Diversion to Non-Competitive/Non-Commercial Outlets, and the Handler Appeal form.
