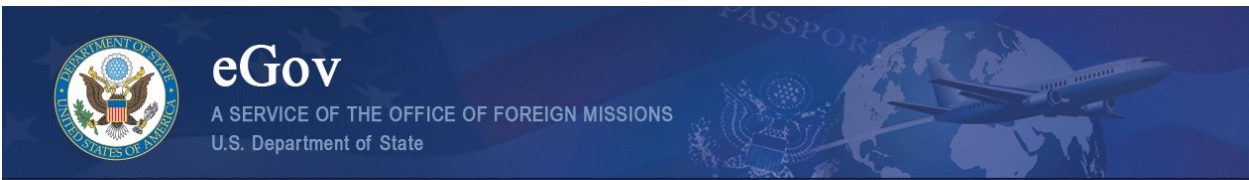




Acknowledgement

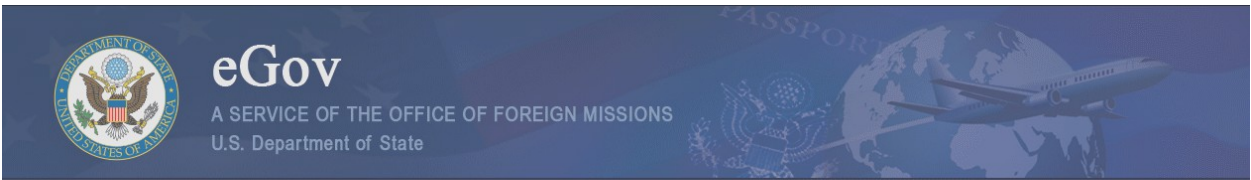
