SUPPORTING STATEMENT FOR PAPERWORK REDUCTION ACT SUBMISSION

Under the current unprecedented national health emergency, Congress and the President have come together to offer relief to those individuals and industries affected by the COVID-19 virus under the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) (Pub. L. 116–136), the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA) (Pub. L. 116-260) and the American Rescue Plan Act of 2021 (Pub. L. 117-2). Institutions eligible for funding under these statutes may elect to voluntarily decline all or a portion of their Higher Education Emergency Relief Fund (HEERF) grant awards, in which case the U.S. Department of Education (the Department) will then deobligate the funds from the institution's G5 account and will later redistribute the funds to other institutions with greater needs due to the coronavirus. In order to process the deobligation and redistribution of these funds more efficiently, the Department is requesting emergency clearance of a short form that will allow these institutions to provide the Department with information regarding the funds being declined.

The information will be used by the Department to deobligate and redistribute HEERF funds.

3. Data collection will be conducted electronically.

This information is not duplicated in any other information collection.

The Department does not believe the requirements will adversely impact any institution that may meet the small entity designation.

If this emergency collection is not approved, the Department will be unable to deobligate and redistribute these funds in a timely manner.
