Respondents will be the FVPSA funded State and Coalition grantees. There are a total of 52 Coalitions and 56 Territories that receive FVPSA funds annually. These grantees are divided into regions and each FVPSA Project Officer will conduct a regional grantee meeting. It is estimated that approximately 25 States (State Administrators) and 25 Coalitions (State Domestic Violence Coalitions) will be represented at each regional meeting (some grantees bring more than 1 representative to the meetings).
