- What is your Home Nation? (text box)

- Do you know what your next position will be? (mc: yes, no)
- How has this course CHANGED your view of the United States? (1 = much worsened, 7 = much improved) (sliding scale)
- What ADVICE would you give to others attending courses in the U.S.? Please do not include any personally identifiable information, such as names of other people, in your response. (Text box)
- Have you previously attended a professional military education course in the United States? (mc: yes, no)
  - o How often do you maintain contact with your professional military education classmates? (mc: never, once a year or less, two to three times a year, four times a year or more)
- Have you attended professional military education courses in other countries? (mc: yes, no)
- Please list the other professional military education courses you have attended in other countries. (Please do not include any personally

identifiable information, such as names of other people, in your response.) (text box)

- o How would you compare your experience studying in the United States to studying in your country or other countries? (mc: Very different, mostly different, mostly similar, very similar)
- The professional military education course(s) I completed prepared me for my job(s). Use a scale from 1 to 7, where 1 = strongly disagree, 4 = neither disagree nor agree, and 7 = strongly agree. (sliding scale)
