A. JUSTIFICATION:

1. Explain the circumstances that make the collection of information necessary. Identify legal or administrative requirements that necessitate the collection of information.

The Department of Veterans Affairs (VA) through its Veterans Benefits Administration (VBA) administers an integrated program of benefits and services, established by law, for Veterans, service personnel, and their dependents and/or beneficiaries. VA may approve leaves of absence under certain conditions under title 38 U.S.C. Chapter 31. Additionally, 38 U.S.C. 501(a) provides VA the authority to collect this information. VA Form 28-1905h, Trainee Request for Leave (Chapter 31, Veteran Readiness and Employment) is necessary in the determination of granting leaves of absence under 38 U.S.C. 3110.

VA Form 28-1905h has been updated, to include:

- The burden has remained the same.
- New standardization data points; to include optical character recognition boxes. This is a non-substantive change.
- Opt-in language for use of the claimant's email. This is a non-substantive change.
- Electronic signature capabilities. This is a non-substantive change.

Note: Due to an increase in staffing resources our Program Office is now requesting to have this collection reinstated with only the non-substantive changes listed above.

2. Indicate how, by whom, and for what purposes the information is to be used; indicate actual use the agency has made of the information received from current collection.

VA Form 28-1905h is used to request leaves of absence as part of the rehabilitation program under 38 U.S.C. Chapter 31. A trainer or authorized school office uses this form to verify the effect of the absence on the claimant's progress in the program. The case manager approves or denies the leave request in accordance with 38 U.S.C. 3110.

3. Describe whether, and to what extent, the collection of information involves the use of automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g. permitting electronic submission of responses, and the basis for the decision for adopting this means of collection. Also describe any consideration of using information technology to reduce burden.

VA Form 28-1905h is available on the One-VA Website in a fillable electronic format. VBA is currently hosting this form on a secure server and does not currently have the technology in place to allow for the complete submission of the form. Validation edits are performed to

assure data integrity. There currently is no utility process in place that will allow the data submitted on the form to be incorporated with an existing centralized legacy database.

- 4. Describe efforts to identify duplication. Show specifically why any similar information already available cannot be used or modified for use for the purposes described in Item 2 above.**

Program reviews were conducted to identify potential areas of duplication; however, none were found to exist. There is no known Department or Agency which maintains the necessary information, nor is it available from other sources within our Department.

The collection of information does not involve small businesses or entities.

VA Form 28-1905h is used to gather the necessary information to determine whether leaves of absence may be justified as part of the rehabilitation plan under 38 U.S.C. Chapter 31. Additionally, the information is used to approve or deny the leave request as outlined in 38 U.S.C. 3110.

The Department notice was published in the Federal Register on June 1, 2021, Volume 86, No. 103, pages 29360 and 29361. No comments were received in response to this notice.

No payments or gifts to respondents have been made under this collection of information.

10. Describe any assurance of privacy to the extent permitted by law provided to respondents and the basis for the assurance in statute, regulation, or agency policy.

The records are maintained in the appropriate Privacy Act System of Records identified as “Compensation, Pension, Education, and Vocational Rehabilitation and Employment Records-VA (58VA21/22/28),” published at 74 FR 29275 on June 19, 2009, and last amended at 84 FR 4138 (February 14, 2019).

11. Provide additional justification for any questions of a sensitive nature (Information that, with a reasonable degree of medical certainty, is likely to have a serious adverse effect on an individual's mental or physical health if revealed to him or her), such as sexual behavior and attitudes, religious beliefs, and other matters that are commonly considered private; include specific uses to be made of the information, the explanation to be given to persons from whom the information is requested, and any steps to be taken to obtain their consent.

There are no questions of a sensitive nature.

12. Estimate of the hour burden of the collection of information:

- a. Number of Respondents is estimated at 30,000 per year.
- b. Frequency of Response is one time.
- c. Annual burden hours are 7,500 hours.
- d. The estimated completion time for each form is 15 minutes.
- e. The respondent population for VA Form 28-190h is composed of trainers, authorized school officials and claimants requesting leaves of absence. VA cannot make further assumptions about the population of respondents because of the variability of factors such as the educational background and wage potential of respondents. Therefore, VBA used general wage data to estimate the respondents’ costs associated with completing the information collection.

The Bureau of Labor Statistics (BLS) gathers information on full-time wage and salary workers. According to the latest available BLS data, the mean hourly wage is \$27.07

based on the BLS wage code – “00-0000 All Occupations.” This information was taken from the following website: https://www.bls.gov/oes/current/oes_nat.htm.

Legally, respondents may not pay a person or business for assistance in completing the information collection. Therefore, there are no expected overhead costs for completing the information collection. VBA estimates the total cost to all respondents to be \$203,025 (7,500 burden hours x \$27.07 per hour).

This submission does not involve any recordkeeping costs.
