**PURPOSE:** The interactive virtual Instructor Led Training (vILT) delivers training to the public on a variety of examination practice and procedure topics. The trainings are derived from the same guidance we provide our experienced patent examiners, and the online format allows participants to remotely attend without the need to travel to USPTO locations. The information collection items included in this Fast Track request—an initial interest request, a needs assessment survey, and a course satisfaction survey—allow the United States Patent and Trademark Office (USPTO) to gauge the interest from potential course attendees in a given course and to determine the successes/shortcomings of an offered course following a stakeholder's completion of the class.

## **DESCRIPTION OF RESPONDENTS:**

The vILT courses are open to all members of the public. Approximately 70% of registrants are registered practitioners and the remainder are inventors or individuals interested in intellectual property.

The USPTO estimates that 100% of the forms and surveys will be conducted online.

**FEDERAL COST:** The estimated 3-year cost to the Federal government uses the combined hourly rate of \$37.45 per hour for a GS-9 step 10 (\$37.45) + \$11.24 (30%) which totals an hourly rate of \$48.69.

<u>The vILT Interest Request</u> will be summarized for each of the 16 sessions, and take about 1 hour to complete and send formal course invitations. This equals 16 total hours. 16 hours \* \$48.69 = \$779. The Needs Assessment Survey will be summarized 4 times a year and take about 2 hours to graphically summarize and distribute. 4 sessions \* 2 hours = 8 hours. 8 hours \* \$48.69 = \$390. The vILT Evaluation Survey will be summarized for each of the 16 sessions, and take about 2 hour to graphically summarize and distribute. 16 sessions \* 2 hours = 32 hours. 32 hours \* \$48.69 = \$1,558.

**Total Federal cost for all 3 items = \$2,727.**
