



## A80B - Privacy Act Statement

**Authority:** The National Housing Act and Section 7(d) of the Department of Housing and Urban Development Act, Section 203, Public Law 89-174; 24 CFR 5.210; 24 CFR 200.1101; 24 CFR 203.35

**Purpose:** The individual's information is generated from form HUD-92900-A and electronically. It is provided to the Single Family Insurance Operations Branch to maintain insurance on endorsed single family loans.

**Routine Uses:** The Single Family Premium Collection Subsystem - Periodic is used to verify payment of annual mortgage insurance premiums. The information will not be disclosed outside HUD without your consent except to verify its accuracy with FHA lenders; to appropriate agencies, entities, and persons when HUD needs to mitigate a breach or incident involving PII; and to authorized federal agencies for collection of funds or authorized inquiries.

**Disclosure:** All the information requested is voluntary. Failure to provide information may delay timely payment of the monthly mortgage insurance premium.

### PUBLIC REPORTING BURDEN

Public reporting burden for this collection of information is estimated to last 9 minutes (.15 of an hour), and includes the time for reviewing instructions, gathering premium payment data, verifying payment data provided, modifying and entering additional case premiums, reviewing, and transmitting the monthly mortgage insurance premium payment. The information entered is used to collect monthly mortgage insurance premium payments from mortgagees electronically as required by 5 CFR 1320.5(b). FHA may report case level mortgage insurance payment information for each FHA mortgage loan insured. FHA mortgage loan participants are not required to respond to this information collection unless a valid, current Office of Management and Budget (OMB) control number is displayed. This data collection has been reviewed by OMB under the Paperwork Reduction Act of 1965, OMB control number 2502-0536, expires 02/28/2022.
