- (2) Check "as heretofore modified" if, and only if, the phrase is applicable.
- (3) The date approving Forest Officer signs this form.
- (4) If contracting party is a **copartnership or LLC**, the Purchaser's Name should be: XYZ Company, by John Doe, a member of the firm. If contracting party is a **corporation**, Purchaser's Name should be XYZ Company, Inc., by John Doe, President (or other officer or agent) and the seal of the corporation must be impressed or indicated. If contracting party is an **individual**, enter their legal name.
- (5) The signature and addresses of two witnesses are required if sale is to other than a corporation.
- (6) The certificate must be completed if the purchaser is a corporation.
