**Permit to Conditionally Import a Dog Inadequately Immunized against Rabies - Single Entry**

In accordance with 42 CFR Section 71.51 of the Public Health Service Foreign Quarantine Regulations, permission is granted to the applicant to import the dog (listed in item 3 below) into the specified port of entry under control of the United States.

Conditions of Issuance	<p>The dog identified in item 3 above is conditionally admitted to the United States, subject to the restrictions of section of 42 CFR 71.51 listed below:</p> <ol style="list-style-type: none"> <li>_____ Confinement for _____ days to complete the 30-day period from the date of initial antirabies vaccination.</li> <li>_____ Confinement until 3 months of age, then initial antirabies vaccination, followed by confinement for 30 days.</li> <li>_____ Confinement until initial antirabies vaccination at destination (within 10 days of entry into the United States), followed by confinement for 30 days.</li> <li>_____ Confinement until booster antirabies vaccination at destination (within 10 days of entry into the United States), provided that initial rabies vaccination was given at <math>\geq</math> 3 months of age.</li> <li>_____ Other restrictions are as follows: _____</li> </ol> <p>The above restrictions are imposed under section 71.51 Title 42, Code of Federal Regulations, and compliance is necessary before the dog is released from confinement.</p> <p>“Confinement” as used above, means restriction of an animal, by the owner or his/her agent, to a building or other enclosure isolated from people and other animals (except for contact necessary for its care); if the dog is allowed out of said enclosure, muzzle the dog and keep it on a leash.</p> <p><small>NOTICE TO PERMITEE: Criminal penalties may be imposed for violating regulations enacted under 42 U.S.C. § 264. Under 42 U.S.C. § 271, as enhanced by 18 U.S.C. §§3559 &amp; 3571, individuals violating a quarantine regulation may be sentenced to one year in jail and/or a maximum fine of \$100,000, if the violation does not result in a death or \$250,000, if the violation results in a death. Violations by an organization are punishable by a maximum fine of up to \$200,000 per violation, if the violation does not result in a death, or \$500,000 per violation, if the violation results in a death.</small></p>
