Agency personnel time to review the form is estimated at 1 hour per form. Based on 394,031 responses per year, then 394,031 hours are estimated personnel hours to review. Grants administrative personnel generally are in the GS9 - 15 range. Based on a step one average of these grades, an average hourly salary is \$39 per hour. Therefore, 394,031 hours x \$39 = \$15,367,209 of estimated annual cost to the federal government to review the form.

#### **15. Program or Burden Change**

The burden hours reported for this ICR only reflects that of HHS. As these ICs are Common Forms, Grants.gov is only required to report the burden for HHS.
