**Principal Purpose(s):** To gather information necessary to budget for the resources to meet the need for Personnel Security Investigations (PSI) for Contractor clearances. DCSA must solicit input from the contractor entities regarding the number of each type of investigation they require for contract performance requiring access to classified information.

**Routine Use(s):** Information collected is compiled to create an aggregate projection of NISP personnel security clearance requirements. Only the aggregate data is reported and all individual Facility Security Officer name and company information is kept in DCSA records

**Disclosure:** Voluntary. However, failure to provide background investigation requirements may adversely impact sufficient funding for these background investigations for clearances.

#### Introduction:

The purpose of this data collection is to gather the information necessary to ensure that funding is available to meet the need for Personnel Security Investigations (PSI) for contractor clearances.

Contractor clearances are part of the National Industrial Security Program (NISP) that DCSA administers on behalf of DoD and 31 other federal agencies. Funding for the associated industry PSIs is handled centrally by DCSA as part of its NISP responsibilities and DCSA is conducting this data collection in order to carry out these responsibilities effectively. Data collection results are critical to DCSA/DoD program planning for NISP security clearances.

Please read all the instructions and follow the prompts to submit your PSI Projected Requirements data collection to Defense Counterintelligence and Security Agency.

If you received this data collection email invitation, DCSA records indicate that you are a proper point of contact to complete this data collection for a specific cleared facility or facilities.

#### General Instructions

- Identify whether your facility is a single submitter, filing a consolidated response, or does not require clearances in the next three fiscal years. The fiscal year runs from Oct 1 to Sep 30.
- Determine whether your PSI requirements are in support of DoD and/or Non-DoD agencies and select all that apply from the drop-down menus.
- You will provide your projections for Tier 5 (Top Secret), Tier 5R (Top Secret Reinvestigation), Tier 3 (Secret and Confidential), and Tier 3R (Secret Reinvestigation) for both DoD and non-DoD agencies.
- If you have an employee who works under multiple cleared contracts who will require a PSI for a clearance, you should only count them once and toward their primary contracting activity (either DoD or Non-DoD). Do not 'double count'.
- The final section of the data collection will provide you with an opportunity to input general comments or comments for a specific fiscal year.
- Do not submit classified information in the comments section. If you believe classified information is essential to your facility's data collection response, contact your Industrial Security Representative for assistance.
