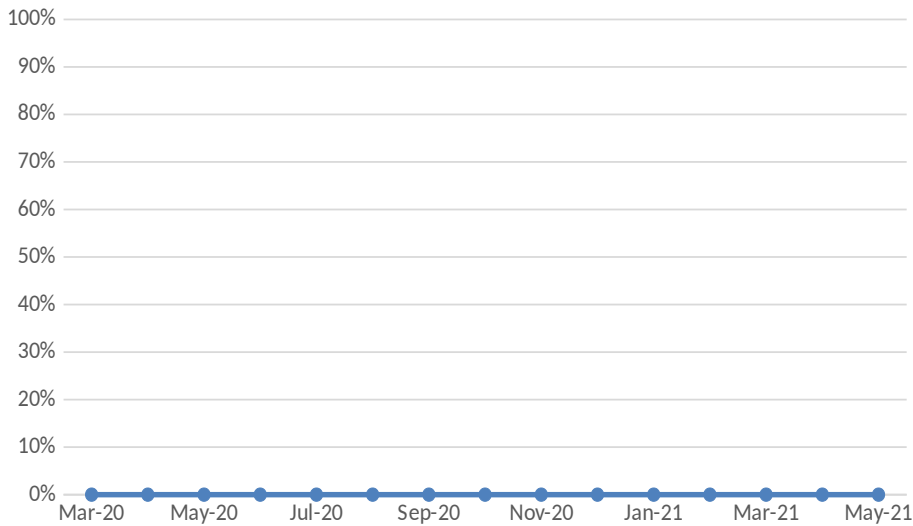




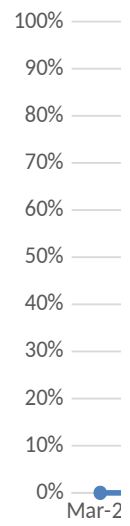
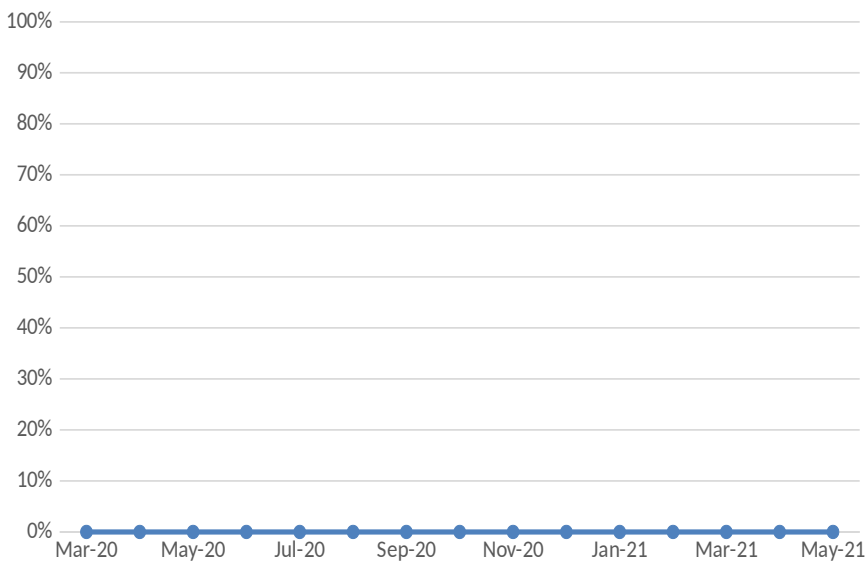

### Measure #1 (SMART Aim): % Children Engaging in EL&L Activities with Caregiver or Family Member

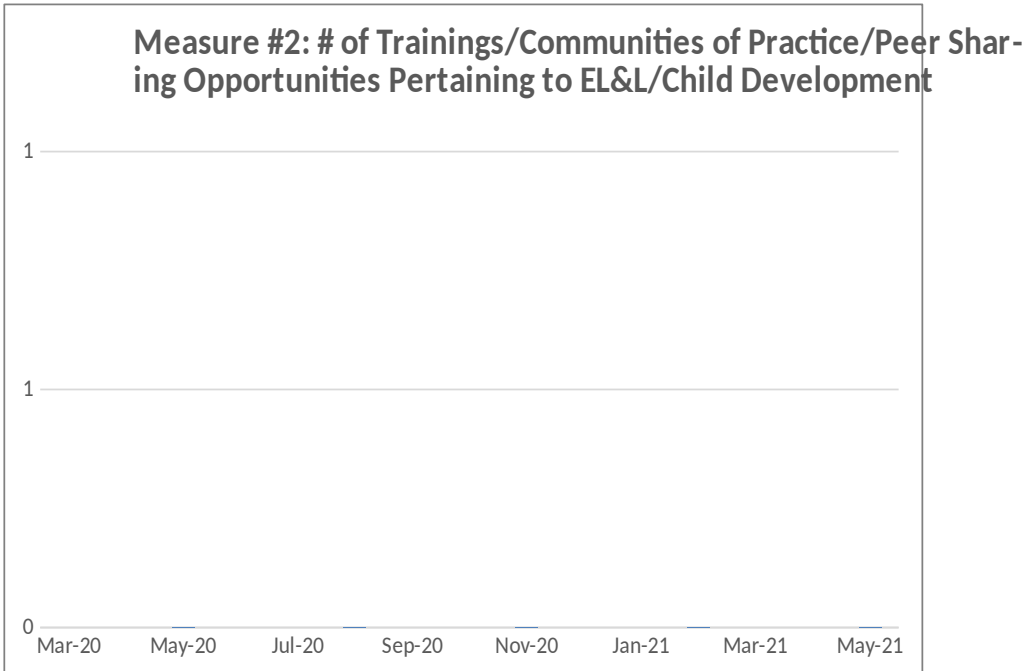
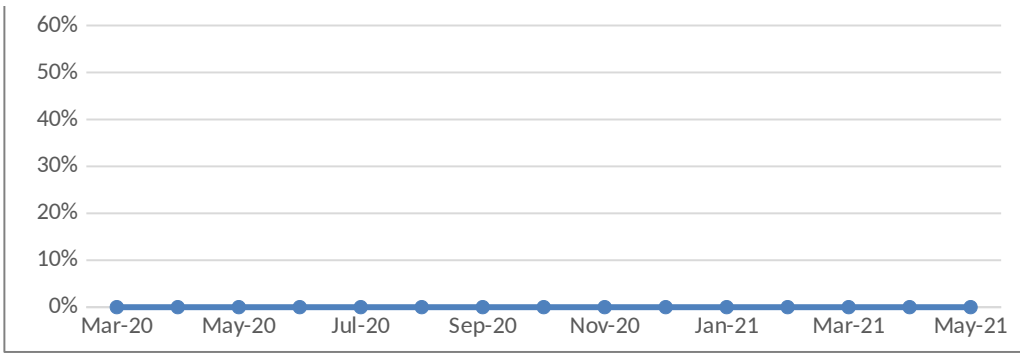


### Measure #4: % Home Visits Where EL&L Content was Discussed



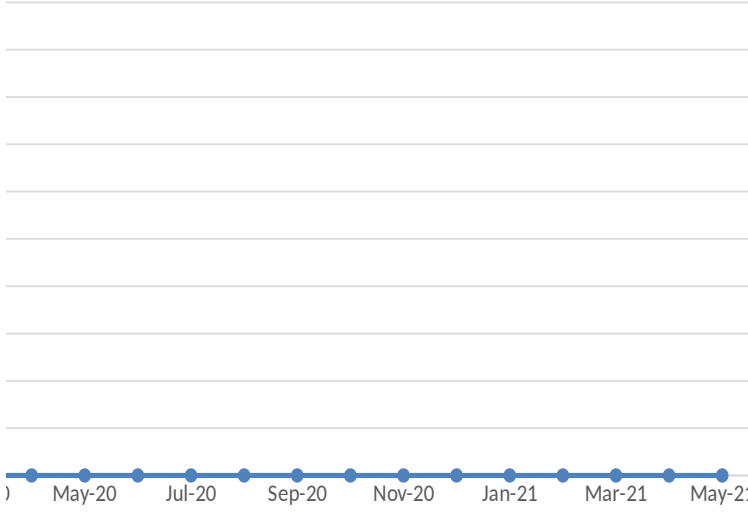
### Measure #7: % Families Receiving the Recommended Number of Home Visits



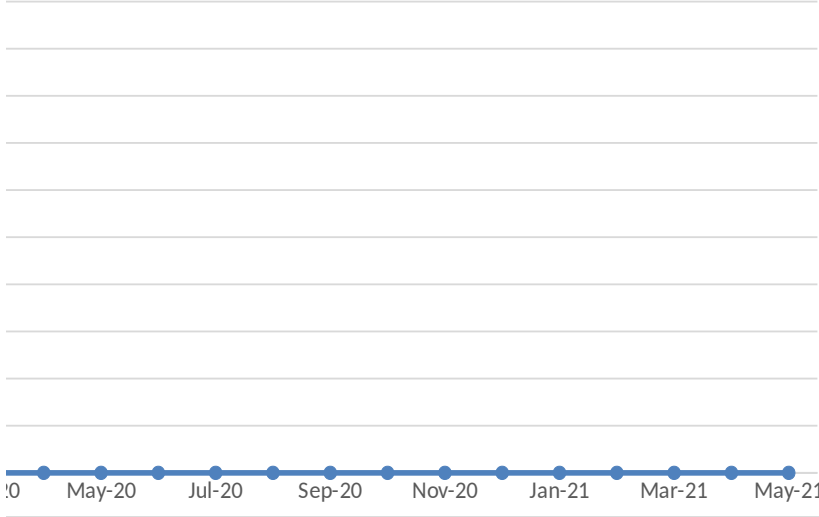
