1. Open the attachment using the password sent to you in a separate email. This attachment lists the location(s) we will ask about.
2. Go to <https://idcf.bls.gov>
3. Enter a 12-digit User ID and the Temporary Password associated with the User ID. These can be found in the first two columns of the PDF attachment, then click *I Accept*.
4. Complete the "Check Email Address", "Enter New User Information", and "Create a Permanent Password" pages.
5. Click *Continue* on the "Confirmation Notice" page.
6. Select "Survey of Respirator Use and Practices" and follow the onscreen instructions to report your data. Click *Submit* when you are finished.

Note: You may log onto the website using your User ID and permanent password at any time during the collection period to make corrections to your data. You can also report for additional Establishment IDs by logging into the survey again, clicking the *Continue* button on the "Dear Employer" page, and then clicking *Add Establishment*.
