

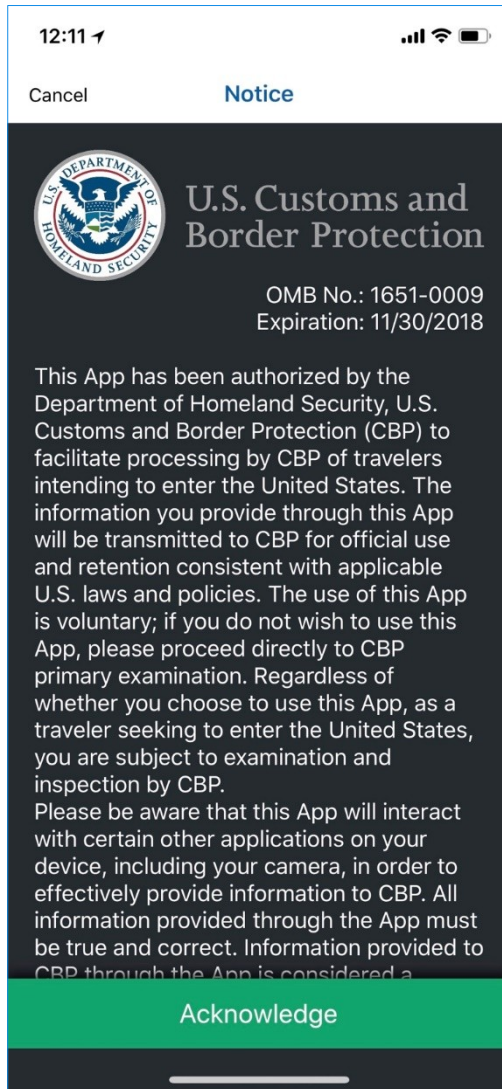

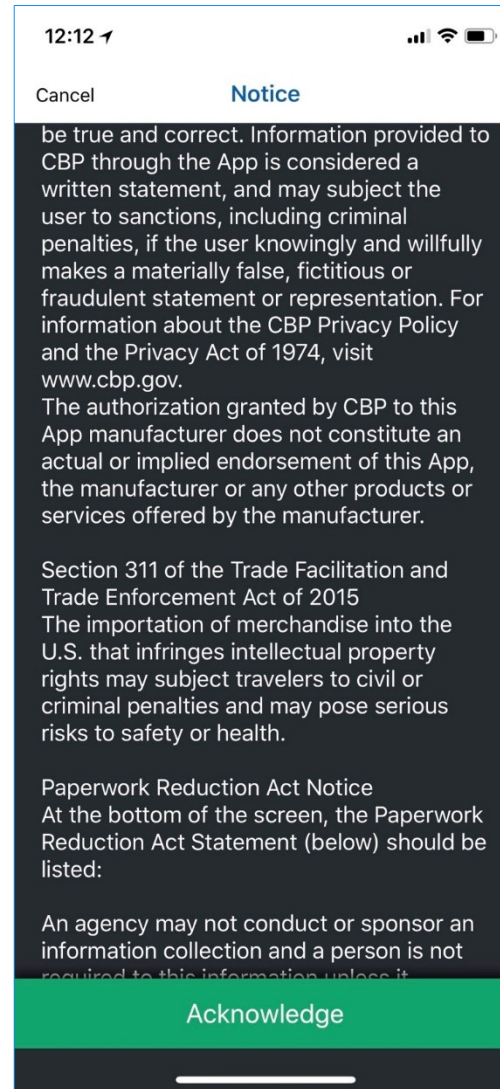

CBP "Box" Screen Progression (1 of 7)

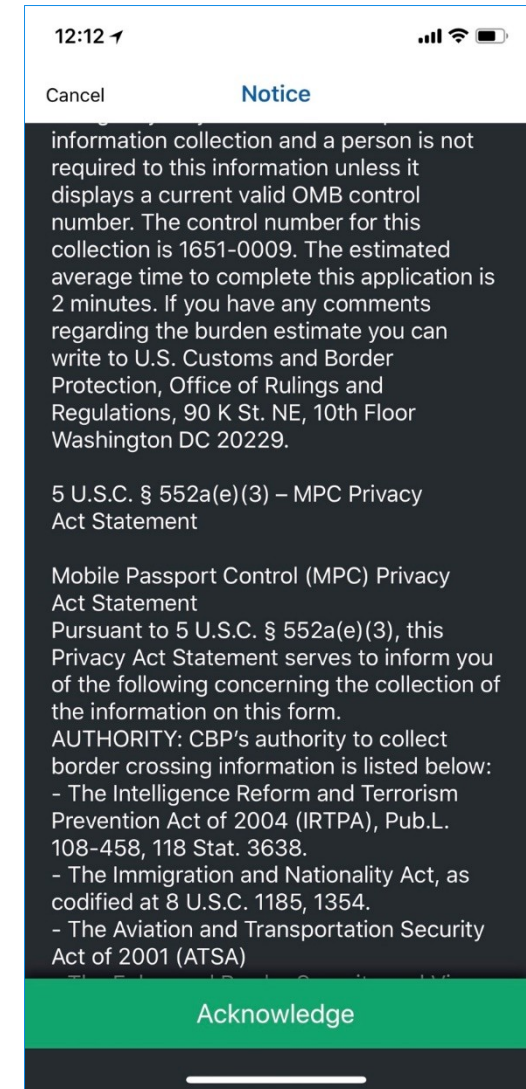

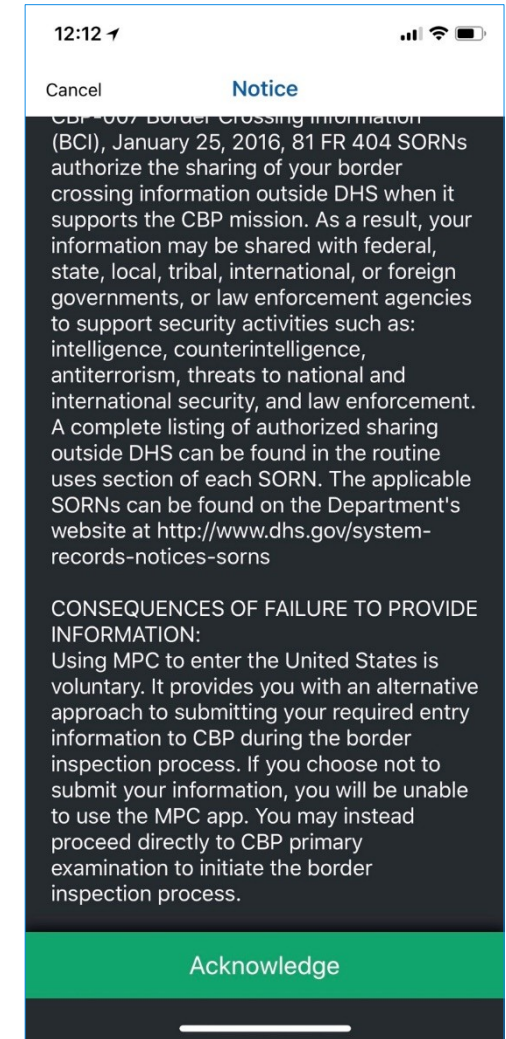





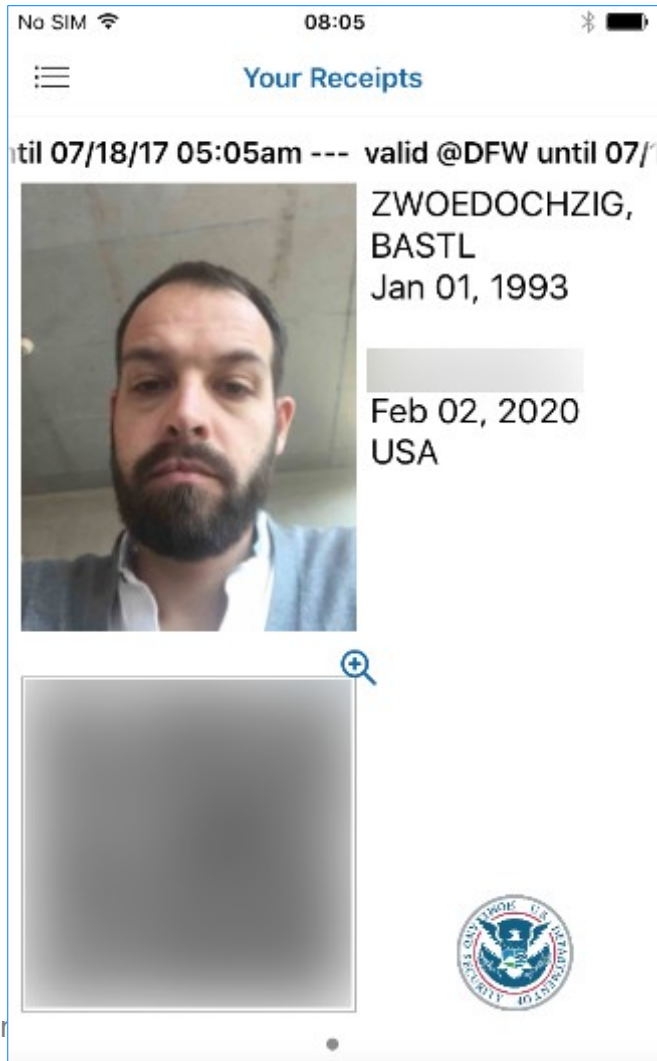
