#### **BURN PERMIT PROCESS**

- Submit a permit application at least one business day before you want to burn.
- Call 208-843-9381 or 800-720-4089 each day you want to burn to find out if it is a burn day. Burn only on BURN DAYS and DURING ALLOWED HOURS.
- 3. If it is a Burn Day, leave a message with your name, phone number and what you are burning.
- 4. Each time you burn, record information in the log to the right. →
- 5. Burner must be prepared to prevent and extinguish escaped burns.
- Applicants must also obtain applicable fire safety permits. Contact your local fire district or sheriff's office for fire safety information.

Smoke impacts on public roads, schools, daycares, medical facilities, elder homes and other sensitive people or areas must be prevented as a condition of this permit. Burning is not permitted during burn bans or air pollution episodes, or when the Nez Perce Tribe or EPA determines that burning will cause an adverse impact to air quality. This permit is part of a federal air quality program administered by the Nez Perce Tribe to control emissions of air pollutants and manage smoke for air quality purposes. These rules apply to any person within the exterior boundaries of the 1863 Nez Perce Indian reservation.

Q: Why do I need a permit?

A: Smoke from open burning is an air pollutant with effects on air quality and public health (especially for children and the elderly).

Q: What are some alternatives to outdoor burning?

A: Chipping and shredding vegetation for composting. Also, household items such as glass, plastics and paper can be recycled and should not be burned.

Q: How can I burn more cleanly?
A: Make sure your fuel is as dry as possible, separate the fire from damp ground and be sure there is enough draft to keep the fire burning hot.

Q: Are there exceptions?A: Cultural, traditional and recreational fires are exempt and do not require a permit.
