## **NOTES TO RECRUITERS**

- Recruit 8 to "seat" 4-6 participants.
- 2 focus groups among AI/AN adults only
- Groups segmented by gender:
  - o 1 group of women and those who would prefer to be grouped with women
  - o 1 group of men and those who would prefer to be grouped with men
- Each group must include a range of:
  - o Ages
  - Education levels
  - Geographic locations (mix of cities/states)
  - o Ideologies
- All participants must not have received any doses of a COVID-19 vaccine or be scheduled to receive a dose in the next two weeks
