

SUPPORTING STATEMENT
FOR PAPERWORK REDUCTION ACT SUBMISSION

1. Explain the circumstances that make the collection of information necessary. What is the purpose for this information collection? The Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) (P.L. 116-260), enacted on December 27, 2020, provided \$22.7 billion for assistance to institutions of higher education (IHEs) under the Higher Education Emergency Relief Fund (HEERF). Pursuant to section 314(d)(6) of CRRSAA, any institution that was required or will be required to remit payment to the Internal Revenue Service for the excise tax paid on investment income of private colleges and universities under section 4968 of the Internal Revenue Code of 1986 for tax year 2019 must notify the U.S. Department of Education (the Department) that it was required or will be required to remit such payment. Further, these IHEs must certify that the institution will not draw down more than 50% of its total allocation under CRRSAA section 314 prior to requesting a waiver under Section 314(d)(6)(B), which permits the Secretary to waive the requirements to reduce a grantee's allocation, if upon application, an IHE demonstrates need for the total amount of funds such institution is allocated under section 314(a)(1) of CRRSAA. The Department is requesting an extension of approval for a short form, currently cleared under emergency processing, that will provide institutions with the opportunity to request this waiver and collect data needed to evaluate their waiver request.

The information will be used by the Department to evaluate requests for waivers of the requirement described above.

Data collection will be conducted electronically.

This information is not duplicated in any other information collection.

The Department does not believe the requirements will adversely impact any institution that may meet the small entity designation.

If this collection is not approved, the Department will be unable to receive and review waiver requests, delaying the release of funds to IHEs and students that are still recovering from the effects of the pandemic.

This information collection does not require any special circumstances.

The Department previously received emergency approval from OMB for this collection. In an effort to comply with the Paperwork Reduction Act, the Department published a combined emergency/60 day notice for public comment on July 12, 2021. Four comments were submitted during the emergency comment period, but none were relevant to this collection.

A 30 day Federal Register notice for public comment will be published as required. The Department will respond to comments received as a result of that notice.
