

SUPPORTING STATEMENT  
FOR PAPERWORK REDUCTION ACT SUBMISSION

**1. Explain the circumstances that make the collection of information necessary. What is the purpose for this information collection? Under the current unprecedented national health emergency, Congress and the President have come together to offer relief to those individuals and industries affected by the COVID-19 virus under the American Rescue Plan Act of 2021 (ARP) (P.L. 117-2). ARP provides funding for proprietary institutions of higher education (IHEs) under the (a)(4) funding stream, to be used solely to make financial aid grants directly to students, which may be used for any component of the student's cost of attendance or for emergency costs that arise due to the coronavirus, such as tuition, food, housing, health care (including mental health care) or child care. This collection includes required certifications that must be completed by proprietary institutions seeking funding under this statute. The Department of Education (the Department) is requesting an extension of approval for this collection, currently approved under an emergency clearance, to allow for outreach to eligible IHEs.

The information will be used by the Department to process grant awards to eligible proprietary IHEs under the ARP (a)(4) grant program. The Department has determined that such a certification form is necessary in order to mitigate the risks identified with making awards to proprietary grant institutions, many of which have never received Federal grant funds outside of the HEERF programs.

Data collection will be conducted electronically.

This information is not duplicated in any other information collection.

The Department does not believe the requirements will adversely impact any institution that may meet the small entity designation.

If this collection is not allowed to proceed, the Department will not be able to fulfill the ARP mandates, and students will not be able to receive the financial assistance authorized by Congress and signed into law by the President.

This information collection does not require any special circumstances.

The Department previously received emergency approval from OMB for this collection. In an effort to comply with the Paperwork Reduction Act, the Department published a 60 day notice for public comment on May 28, 2021. The Department received two comments, only one of which was substantive. Staff have reviewed and responded to the substantive comment.

A 30 day Federal Register notice for public comment will be published as required. The Department will respond to comments received as a result of that notice.

No payments or gifts have been provided to respondents.

We estimate that it will take 1,757 respondents 878.5 total hours to complete and submit the required certifications.
