G-28, Notice Of Entry Of Appearance As Attorney Or Accredited Representative

Form G.38, The Notice of Entry of Appearance as Attorney or Accredited Representative is for attorney and accredited representatives to provide information to establish their eligibility to appear for and act on behalf of an applicant, petitioner, requester, beneficiary or derivative, or respondent in immigration matters. An atomsy or according representative must complete and submit a new Form G-28 for each client case. The Form G-24 can be started along with a client's new case or it can be added to a client's alongly-submitted case. UCIS will only recognize a completed Form G-28 once the client has reviewed and signed the form.

Each attorney or accredited representative appearing in a case must submit their own form G-28 and USCIS only recognizes one form G-28 at a time.
