Purpose - Reports are required to obtain data for use in estimating the international transactions accounts of the United States.

Authority - This survey is being conducted under the authority of the International Investment and Trade in Services Survey Act (P.L. 94-472, 90 Stat. 2059, 22 U.S.C. 3101-3108, as amendedhereinafter "the Act"), and the filing of reports is mandatory under Section 5(b)(2) of the Act (22 U.S.C. 3104). Regulations for the survey may be found in 15 CFR Part 801.

Penalties - Whoever fails to report may be subject to a civil penalty and to injunctive relief commanding such person to comply, or both. These civil penalties are subject to inflationary adjustments. Those adjustments are found in 15 CFR 6.4. Whoever willfully fails to report shall be fined, and, if an individual, may be imprisoned for not more than one year, or both. Any officer, director, employee, or agent of any corporation who knowingly participates in such violations, upon conviction, may be punished by a like fine, imprisonment, or both. b. A U.S. airline operator that had total covered revenues AND total covered expenses below the reporting threshold must complete pages $1-3$, and is only required to report total revenues and expenses in question 8. The U.S. airline operator also has the option of providing additional information, on a voluntary basis, on pages 4-7.
c. A U.S. airline operator that had no transactions of the types covered must complete pages 1-3.
