Race/Ethnicity	Hispanic, All Races	A person of Cuban, Mexican, Puerto Rican, South or Central America, or Spanish culture or origin regardless of their race.
Race/Ethnicity	Black or African American	A person having origins in any of the original people of the African Continent (i.e., Nigerian, Kenyan), African American, or Haiti, or Carribean Islands.
Race/Ethnicity	Asian	A person having origins in any of the original peoples of the Far East, Southeast Asia, or the Indian subcontinent including, for example, Cambodia, China, India, Japan, Korea, Malaysia, Pakistan, the Philippine Islands, Thailand, and Vietnam.
Race/Ethnicity	Native hawaiian or Other Pacific Islander	A person having origins in any of the original peoples of Hawaii, Guam, Samoa, or other Pacific Islands.
Race/Ethnicity	American Indian/Alaskan	A person having origins in any of the original peoples of North and South America (including Central America) and who maintains tribal affiliation or community attachment.
Race/Ethnicity	White	A person having origins in any of the original peoples of European, Middle Eastern, or North Africa.
Rural/Urban	Rural	Completely rural or less than 2,500 urban population, adjacent to a metro area. Completely rural or less than 2,500 urban population, not adjacent to a metro area.
Rural/Urban	Urban	Urban population of 20,000 or more, adjacent to a metro area. Urban population of 20,000 or more, not adjacent to a metro area. Urban population of 2,500 to 19,999, adjacent to a metro area. Urban population of 2,500 to 19,999, not adjacent to a metro area.
Rural/Urban	Metro	Counties in metro areas of 1 million population or more. Counties in metro areas of 250,000 to 1 million population. Counties in metro areas of fewer than 250,000 population.
