Advance Letter/Early Bird Offer

The Advance letter changes slightly every round and is usually signed by the director. The following example uses the advance letter from the NLSY97 Round 19, with a sentence from the Y79 Early Bird and the confidentiality statement included in the COVID-19 supplement.
