Column 1 EMPLOYEE COUNT

The total number of persons who worked or received pay for any part of the pay period that includes the 12th of the month. Include employees who worked only during the school year but received pay for the whole year.

Include:

- Counselors, librarians, and coaches
- Custodial and cafeteria employees
- Full-time or part-time employees
- Other non-teaching personnel
- Paid members of religious orders
- Students employed on your payroll
- Teachers, administrators, and trainees
- Employees on active duty, if receiving pay from employer
- Employees on paid sick or other leave
- Employees on paid vacation

Exclude:

- Outside contractors and their employees
- Pensioners
- School trustees and school board members serving without pay
- Volunteers
- Employees on active duty, if not receiving pay from employer
- Employees on leave without pay for the entire pay period
- Employees on strike the entire pay period

Column 2 WOMEN EMPLOYEE COUNT

Enter the number of employees from Column 1 who are women.

Column 3 FACULTY MEMBERS

Enter the number of employees from Column 1 who are regular members of the faculty of this institution or school system.
