Selection Process

Selection decisions will be based on (1) sector mix, (2) appropriate level within the organization, (3) likelihood to follow through, (4) diversity, and (5) no direct competitors with participating award recipients or other Fellows. Candidates will be notified of the decision by January 10, 2022. Tuition payment of \$28,000 is due by February 18, 2022. The fee covers all materials, as well as a standard hotel room and at least four meals for each session.
