**TITLE OF INFORMATION COLLECTION:** OMB Form No. 0917-0036, Patient Satisfaction Survey, at Cheyenne River Health Center

**PURPOSE:** The information obtained from the customer satisfaction surveys provides feedback to the provider and care teams about the patient’s experience of care. This information is used to make improvements in patients’ care at the facility.

**DESCRIPTION OF RESPONDENTS:** The patient satisfaction survey is made available to patients on a voluntary basis at the end of their visit. Patients are chosen randomly and information is collected on approximately 10-15 patients per provider per month. There is no personally identifiable information on the survey. There are 13 questions based on the patient experience at the Cheyenne River Health Center. Users will need to record a response from #5 (Excellent) to #1 (Very Poor) for questions 1-10 and a response from “Strongly Agree” to “Strongly Disagree” for questions 11 and 12, and “Very sure or No health problems” to “Not at all” to question 13.
