**FEDERAL COST:** The estimated annual cost to the Federal government is approximately \$2,232 annually. These costs are comprised of the following: Creating reviewing, implementing, and maintaining the functionally of the IHS Clinical Rounds survey. One staff takes 30 minutes at \$31 per half hour (based on \$62 per hour) to complete these functions for 1 course per month, at 12 courses annually, which computes to \$31 x 12 months = \$372.

In addition, 5 support staff review the completed surveys at the same rate and time frames, at  $372 \times 5 \text{ staff} = 1,860$ .
