The breakdown of costs are as follows:

- One employee spends 5 minutes, costing \$5 (based on \$60 per hour), to create, implement and maintain one survey per course. IHS offers approximately 30 courses annually x \$5 each = \$150
- Five employees spend 5 minutes each at \$5 (based on \$60 per hour) to review survey responses. IHS offers approximately 30 courses annually = \$150 x 5 employees = \$750

Total cost = \$900 annually
