All personally identifiable information (PII) will be removed from the files prior to uploading using MOVEit, an online platform for data sharing which meets FedRAMP requirements. Survey Analysis: Univariate statistics across systems will be performed on survey data, including means, medians, and standard deviations. Distributions of continuous variables will be plotted and frequency tables created.
