Criteria for Registration:

For the purposes of ECID, an early career investigator is an individual with interest in global cancer research, who is affiliated with an institution that is engaged in cancer research or research training, and meets all the following criteria:

- Education:
 - Has either completed a masters or medical/doctorate degree within the last 15 years, or
 - Is currently enrolled in a medical/doctorate degree program
- Has not received a research grant from the NIH (K or R equivalent) or other international funding organization as principal investigator
