**Date Rebuilt:** Date of redelivery if vessel was substantially reconstructed.

Canal Tonnages: Suez and Panama as applicable

Normal Operating Speed: Normal operating speeds, loaded and ballast.

**Daily Fuel Consumption:** Fuel consumed by specific type of fuel per day at sea and in port.

Tankers should provide standing and pumping separately.

Provide fuel consumption in metric tons or gallons.

Capitalized Vessel Costs: For each capitalized item, provide the amount of capitalization

and the interest rate associated with the capitalization, if secured by mortgage. If the interest rate is variable, provide the formula. If the interest rate is subject to change or renegotiation, provide the new interest rate prior to implementation of the change.

Certification Statement: All information submitted to MARAD must be certified by a

responsible officer of the company. A cover letter listing all enclosures by vessel and certifying their accuracy can be used

as an alternative to vessel by vessel certifications.
